The following message was read, agreed to, and sent to the house of delegates by the clerk.

BY THE SENATE, Dec. 9, 1812.

Gentlemen of the House of Delegates,

We agree to go immediately into the appointment of directors on the part of this state, in the several banks, agreeably to your message. No person is put in nomination by us, in addition to those named by you. We have appointed Messrs Brown and Holbrook to join the gentlemen named by your house to count the ballots and report thereon.

By order, THO'S. ROGERS, Clk.

On motion, Ordered, that the bill entitled, an act for the encouragement of learning and erecting schools in the several counties within this state, for the renewal of the charters of the several banks therein mentioned, and for other purposes, be committed to a special committee. Ordered, that Messrs Lloyd, Tabbs and Hollingsworth, be the said committee.

A petition from Catharine Keyser, of the city of Baltimore, praying a divorce, was preferred, read

and referred to Messrs Stephen, MacCreery and Hawkins, to consider and report thereon.

The bill entilled, an act to prevent trespases in Allegany county, was read the second time, passed,

and sent to the house of delegates by the clerk.

The senate proceeded to the election on the part of the state of two directors for the Union Bank of Maryland; two for the Mechanics Bank of Baltimore; one for the Commercial and Farmers Bank of Baltimore; two for the Farmers Bank of Maryland, at Annapolis; two for the branch of said Bank at Easton; two for the Hager's town Bank, and one for the Elkton Bank of Maryland; the ballot box being prepared, the ballots were deposited therein, sealed up and delivered to the committee of the senate appointed to meet the committee of the house of delegates, who retired to the conference room, and after some time returned and reported that Richard K. Heath had forty five votes, John E. Dor sey thirty nine votes, Elias Glenn thirty six votes, James Caldwell thirty five votes, and Samuel Chase one vote, as directors for the Union Bank of Maryland; that Christopher Raborg, junr. had forty four votes, George Taylor forty four votes, Tobias E. Stansbury, thirty six votes, Peter Little thirty for the Christopher Raborg, peter Little thirty for the Christoph Little thirty five votes, and Peter Willis one vote, as directors for the Mechanics Bai.k of Baltimore; that Edward Harris had forty four votes, and William Pechin, thirty-five votes, as directors for the Commercial and Farmer's Bank of Baltimore; that Thomas H. Bowie had forty-four votes, Daniel Murray forty four votes, William Kilty thirty six votes, and Nicholas Brewer thirty six votes, as directors for the Farmers Bank of Maryland, at Annapolis; that David Kerr, junr. had seventy three votes, Tench Tilghman forty four votes, and Jacob Gibson thirty six votes, as directors for the branch Bank at Easton; that Thomas B. Hall had seventy three votes, Joseph Milhenny forty four votes, and Frisby Tilghman thirty six votes, as directors for the Hager's-town bank; that John Frey had only three votes, and Edward H. Veazey thirty six votes, as director, for the Elkton Bank of Mary-and. Whereupon, it is declared in the senate, that Richard K. Heath and John E. Dorsey, or the Union Bank of Maryland; Christopher Raborg, junr. and George Taylor, for the Mechanics Bank of Baltimore; Edward Harris, for the Commercial and Farmer's Bank of Baltimore; Thomas H. Bowie and Daniel Murray, for the Farmers Bank of Maryland, at Annapolis; David Kerr, junr. ad Tench Tilghman, for the Branch Bank at Easton; Thomas B. Hall and Joseph Mellhenny, for he Hager's town bank, and John Frey, for the Elkton Bank of Maryland, are duly elected directors -In the part of the state, for and during the time prescribed by law. The senate adjourns until to morrow morning 9 o'clock.
