1st. Strikeout the words "except such" in the 7th line of the 21st page, and insert "and of the rents of all such parts of said road."

2nd. Strike out the words "subscribers to the said companies stock," in the 10th line of the 21st

page, and insert, " stockholders of said company."

3rd. Strike out from the second "the" in the 11th line of the 21th page, to the word "as" in the 12th line of the same page, and insert " completing said road."
