would be had policy even if it were justifiable to break upon the stock or actual principle of the state, and as it is impossible for your committee to single out from the applicants any partiular case or cases, more pressingly demanding our interference than the rest, and considering the nature of the claims, however reluctantly, we feel it our duty to recommend that the whole be rejected. At a future time, or as soon as appropriations already made are discharged, the annual receipts into the treasury will enable the legislature to meet these applicants, and give them a reception more favorable.
