The bill entitled, a supplement to the act entitled, an act to incorporate a company for the purpose of cutting and making a canal between the river Delaware and Chesapeak Bay, was read the second time, passed with the proposed amendment, and sent to the house of delegates by the clerk.

Amendment peoposed. After the word " aforesaid" in the 8th line of the 3d page insert " And be it enacted, that this act shall not take effect unless the legislature of Pennsylvania shall pass or shall have passed a lawdeclaring that in consideration of the act of the legislature of Maryland, incorporating said Canal Company, the River Susquehannah from Columbia to the Maryland line shall forever hereafter be a highway,

and that individuals or bodies corporate may at all times remove obstructions therein."

The clerk of the house of delegates delivers a bill entitled, an act to make public a road from Hane cock in Washington county, to Cumberland in Allegany county, and for other purposes; a bill entitled, an act authorising John Newton, late sheriff and collector of Dorchester county to complete his collections, severally passed by that house Dec. 17th, 1812; a bill entitled, an act for the relief of Joshua Taylor, an insolvent debter of Baltimore county; a bill entitled, an act for the relief of John Messler and David Rinehart, trustees of James Farquhar of Frederick county; a bill entitled, an act to authorise voters to pass through turnpike gates free of toll on days of election; a bill entitled, an act to authorise the levy court of Baltimore county to remit a part of the money paid by James Fletch er for the materials of the old court house of said county; a bill entitled, an act to establish a bank and incorporate a company under the title of the Bank of Salisbury; a bill entitled, an act for there lief of Rackel Roberts of the city of Annapolis; a bill entitled, an act to make public an old road leading from John Stump's Rock Run Mill in Harford county; a bill entitled, an act for the relief of William Smith and others of the city of Baltimore; a bill entitled, an act authorising Benjamin Leitch former collector of Calvert county to complete his collections, severally passed by that house Dec. 18, 1812; and the following resolution: Y THE HOUSE OF DELEGATES, Dec. 18, 1812.

Resolved, That Col. William Richardson, appointed treasurer of the Eastern Shore of Maryland he, and he is hereby required, before he proceeds to execute the duties of his said office, to give bond to the state in the penalty of twenty thousand dollars, with at least two securities, to be approved of by the governor and council, for the due and faithful performance and discharge of all the duties of him

Resolved, That William Chambers, Esq. late treasurer of the Eastern Shore of Maryland, is here. by required forthwith to deliver unto Col. William Richardson of Caroline county, the present treasurer for the Eastern Shore of Maryland, all money in the treasury, books of accounts and other papers appertaining to said treasury.

By order, UPTON S. REID, Clk. Which were severally read the first time and ordered to lie on the table.

The senate proceeded to the election of a person to be recommended to the executive, to be commissioned as Register of Wills for Harlord county; the ballot box being prepared, the ballots were deposited therein, sealed up and delivered to the committee of the senate appointed to meet the committee of the house of delegates, who retired to the conference room, and after some time returned and reported that Samuel Richardson had fifty eight votes, and William D. Lee twenty three votes.

Whereupon it is declared in the senate, that Samuel Richardson is duly elected for such recom-

mendation.

The bill entitled, an act for opening and extending Low street in the eastern precincts of Baltimore, was read the second time and will pass with the proposed amendments.
