Mr. Potts delivers a bill entitled, an act for the removal of the public records of the state, and of the several counties therein mentioned, and for the adjournment of several of the courts of law in this state ; which was read the first time and ordered to lie on the table.

Mr. Donaldson delivers a petition from a committee appointed by the committee of supplies of the city of Baltimore, praying that a regiment of one thousand men may be raised in the city of Baltimore, to serve during the war, unless sooner discharged, for the defence of the city of Baltimore, and such other parts of the state as the executive may direct ; which was read and referred to the committee on those parts of the governor's message which relate to the defence of the state.

On motion by Mr. Wilson, the following message was read, agreed to, and sent to the senate.

BY THE HOUSE OF DELEGATES, May 20, 1813.

Gentlemen of the Senate,

Your message of this morning, in reply, on the subject of the election of a senator to the senate of the United States, has been received. We are now ready to proceed to the election. Mr. Blackstone delivers a bill entitled, an act for the relief of Peter A. Carnes, of St. Mary's county, which was read the first and second time by special order, passed and sent to the senate.

The clerk of the senate delivers the bill entitled, a supplement to the act entitled, an act to provide for the appointment of commissioners for the regulation and improvement of Snow Hill, in Worcester county, and the bill entitled, a further additional supplement to the act entitled, an act to incorporate companies to make several turnpike roads through Baltimore county and for other purposes, severally endorsed, will pass ; ordered to be engrossed. And the following message.

BY THE SENATE, May 20, 1813.

Which was read. Also a bill entitled, a supplement to an act entitled, an act for opening and extending Aisquith street, in the eastern precincts of Baltimore, passed by the senate May 20, 1813 ; which was read the first and second time by special order, passed and sent to the senate.

The house proceeded to the election of a senator to represent this state in the senate of the United States, and the ballots being deposited in the ballot box, the gentlemen named to strike retired, and after some time returned and reported that Robert H. Goldsborough, Esq. was elected ; *Whereupon,*

Resolved, that Robert Henry Goldsborough, Esq. be, and he is hereby declared to be, the senator to represent this state in the senate of the United States.

Mr. Donaldson delivers a bill entitled, an act for laying an additional tax on property within the city and precincts of Baltimore ; which was read.

Mr. Potts delivers a bill entitled, a supplement to an act entitled, an act authorising Elizabeth Luckett, of Frederick county, to remove certain negroes into the state of Maryland, passed at November session, eighteen hundred and twelve ; which was read the first and second time by special order and passed.

The clerk of the senate delivers a bill entitled, a supplement to an act entitled, an act authorising James Sloan, senr. of the city of Baltimore, as attorney for Dr. Joseph Mackrill, to execute a deed to Edward Harris, for the lands therein mentioned, passed by the senate May 20, 1813 ; which was read.

Mr. Plater delivers a bill entitled, an act to provide further means of defence for the state ; which was read.

The clerk of the senate delivers the resolution relative to a deputation to the general government, endorsed, assented to, with the proposed amendment, which amendment was read and assented to.

Mr. Dorsey from the committee to whom were referred those parts of the governor's communication which relate to the expences incurred and to be incurred by calling out the militia, delivers a bill entitled, an act to provide for the settlement of claims arising from the past or future employment of the militia of this state ; which was read.

The house adjourns until to morrow morning nine o'clock.

FRIDAY, May 21, 1813.

THE House met.—Present the same members as on yesterday.—The proceedings of yesterday were read.

Mr. J. Stewart delivers a bill entitled, an act authorising Thomas Ennalls, late sheriff of Dorchester county to complete his collections ; which was read.

On motion by Mr. Dorsey, leave given to bring in a bill providing for the calling out and detaching the militia of this state. Ordered, that Messrs Dorsey, Somervell and Potter, be a committee to prepare and bring in the same.
