legally held in the district No. 4, they are elected by a majority of the legal veters of county: that fifty, or upwards of voters were received in favour of the petitioners in the county aforesaid, who were not entitled to vote in said county; that various fraudulent means successfully practised to impose upon the judges the votes of persons of foreign birth, were not naturalized citizens of the United States, or were not bona fide inhabitants of the county, or were otherwise not entitled according to law to vote at said election. The offer to go into proof to substantiate these facts if a full scrutiny can be obtained. the committee do not conceive that the scrutiny thus proposed, however desirable and investigation might be, can be now properly instituted, because the committee are decided opinion, that the return itself as made by the four judges of election of Allegany county available and sufficient, according to the foregoing premises, to entitle all the sitting hers from said county to the seats which they now hold under the decision already by the house.

The committee of Elections and Privileges therefore submit the following resolution

Resolved, That Messrs. William Hilleary, George Robinett (of Nathan,) George M'Com and Beal Howard, delegates returned from Allegany County, are duly entitled to retain seats as members of this house.
