

TUESDAY, *December 14, 1813.*

THE House met.—Present the same members as on yesterday.—The proceedings of yesterday were read.

Mr. Donaldson delivers a petition from Joshua Dorsey, of the city of Baltimore, praying a special act of insolvency : which was read and referred to Messrs Donaldson, Randall and Warner.

Mr. Jones delivers a petition from Richard Taylor, of Montgomery county, a revolutionary soldier, praying relief ; which was read and referred to Messrs Jones, Kilgour and Riggs.

Mr. Burgess delivers a petition from Richard Wilson, a revolutionary officer, stating that there is a balance of pay due to him, and praying compensation : which was read and referred to Messrs Burgess, Duvall and Wright.

Mr. Tilghman delivers a petition from sundry inhabitants of Washington county, praying that a bank may be established at the town of William's port, by the name of the Conococheague bank ; which was read and referred to Messrs Tilghman, Mason and Gabby.

Mr. Kershner delivers a petition from Christian Orendorff, an officer of the revolutionary war, praying compensation for his services ; which was read and referred to Messrs Kershner, Gabby, and Tilghman.

The speaker laid before the house a report of the clerk of Frederick county court, relative to the attendance of the judges ; which was read and referred to the committee of grievances and courts of justice.

Mr. Donaldson delivers a bill entitled, an act for the relief of Joshua Dorsey, of the city of Baltimore, which was read the first and second time by special order, and the question put, Shall the said bill pass ?

So it was resolved in the affirmative and the bill sent to the senate

The bill entitled, an act to settle and ascertain the salary of the members of the council for the ensuing year, was read the second time, passed and sent to the senate.

The bill authorising a lottery for completing the German Lutheran Church, in Taney-town, in Frederick county ; the bill for the relief of Ann Gentle, Sylvester Hunt and Allen Demar ; the bill for the relief of James Rea, of Harford county ; the bill for the relief of Sarah Wooters, of Caroline county ; and the bill entitled, an act to repeal an act entitled, an act to encourage the destruction of crows in the several counties therein mentioned, so far as the same relates to Saint Mary's and Harford counties, were sent to the senate.

On motion by Mr. J. H. Thomas, the following message was read, agreed to, and sent to the senate.

Resolved, That the treasurer of the Western Shore of the state of Maryland, pay out of any unappropriated money in the treasury, into the treasury of the United States, agreeably to the provisions of the seventh section of the act of the congress of the United States of America, entitled, an act to lay and collect a direct tax within the United States, such sum of money as by the said act directed to be assessed and collected in the state of Maryland.

Mr. Donaldson delivers a petition from Mark Pringle of the city of Baltimore, praying the repeal of the act for the extension of Green-street ; which was read and referred to Messrs Donaldson, Stansbury and Warner.

On motion by Mr. Blake, the following message was read, assented to, and sent to the senate :
