So it was unanimously resolved in the affirmative.

The amendments proposed by the senate to the bill entitled, an act to establish a bank, and incorporate a company under the title of the Bank of Somerset, were read the second time, assented to, and the bill ordered to be engrossed.

Mr. Wilson delivers a bill entitled, an act relating to the election districts in Worcester county; which was read the first and second time by special order and passed.

Mr. Dorsey delivers a petition from Edward Timmins, of Anne-Arundel county, praying that the levy court may be authorised to levy a sum of money for his support; which was read and referred to Messrs. Dorsey, Belt and Sellman.

Mr. Donaldson delivers a bill entitled, an act to authorise Gustavus Robert Alexander Brown, and Caroline his wife, of Prince William county, in the state of Virginia, to convey certain property in the precincts of Baltimore city, in Baltimore county; which was read.

The bill from the senate entitled, an act to open and extend Queen street, in the city of Baltimore; the bill entitled, an act for the relief of Jonathan Cox, of Allegany county; and the bill entitled, an act relating to femes covert, were severally read the second time and passed.

The bill from the senate entitled, an act for the benefit of David Williamson, was read the second time, and on motion by Mr. Dorsey, the question was put, that the house receive the following proviso, as an amendment to the last section of the bill. "Provided that nothing herein contained shall impair or affect the rights of any person or persons whatsoever, acquired previous to the passage of this act." Resolved in the affirmative. The question was then put, shall the said bill pass? Resolved in the affirmative.

The clerk of the senate delivers the bill entitled, an act to lay out and open a road in Worcester Hundred, in Worcester county, endorsed, "will pass" Ordered to be engrossed.

The resolution directing an index to be made to the laws, and resolutions passed since the year 1799, was read the second time, & on motion by Mr. Dorsey, the question was put, that the house receive the following as an amendment thereto? Strike out the words "such of the acts of the present session as are required to be furnished to the several courts and judges thereof," and insert "the acts of the present session of Assembly, to such persons and authorities as are by law entitled to receive the said acts." Resolved in the affirmative. The question was then put, that the house assent to the said resolution. Resolved in the affirmative.

Mr. Warner from the committee reports without amendment, the bill entitled, an act to open and extend Franklin street, in the western precincts of Baltimore; which was read.

On motion by Mr. Bayly, the following resolutions were read:

Resolved, That the governor of Maryland, as commander in chief of the militia when in actual service, is entitled to the pay and rations of a Major General of the militia.

Resolved, That the council be, and they are hereby authorised, to liquidate the account of his excellency the governor, for services that have been or shall be rendered as commander in chief of the militia of this state, while in actual service, and that the treasurer of the western shore be, and he is hereby directed, to pay the amount, when so ascertained by the council, out of any unappropriated money in the treasury.

On motion by Mr. Howard, leave given to bring in a bill entitled, a supplement to the act entitled, an act for the speedy recovery of small debts out of court, and to repeal the acts of assembly therein mentioned. Ordered, That Messrs. Howard, Dorsey and Martin be a committee to prepare and bring in the same.

On motion by Mr. Howard, leave given to bring in a bill entitled, a supplement to the act entitled, an act to reduce into one the several acts of assembly respecting elections, and to regulate said elections; Ordered, That Messrs. Howard, Mason, John H. Thomas, Dorsey and Wilson be a committee to prepare and bring in the same.

The house according to the order of the day proceeded to the second reading of the bill entitled, an act to open and make public a road therein mentioned in Baltimore county. And on motion by Mr. Howard, the question was put, that the further consideration thereof be postponed until Friday next? Determined in the negative.

On motion by Mr. Parnham, the question was put, that the further consideration thereof be postponed until five o'clock this evening? Resolved in the affirmative.

Mr. Lecompte delivers a bill entitled, an act to lay out and open a road in Dorchester county; which was read.

Mr. Wilson from the committee delivers the following report:

The committee appointed on so much of the communication of the executive of this state, dated December 8th, 1813, as relates to the loan made by virtue of the resolve of the last General Assembly, together with such parts thereof as concern the financial resources of this state, and to whom was referred the resolution relative to the payment out of the treasury, of the quota of this state of the direct tax, imposed by an act of Congress entitled, an act to lay and collect a direct tax within the United States; report that Congress at their last session passed sun-
