VOTES AND PROCEEDINGS

Gentlemen of the House of Delegates,

We have received your message requesting a reconsideration of the bill entitled, an act to repeat so much of the seventh section of the act of assembly, passed at November session, eighteen hundred and seven, entitled, a further supplement to the act entitled, an ct for the regulation and improvement of Denton, in Caroline county, as prohibits the raising and running at large of swine in the village of Denton aforesaid. The senate having acted with due deliberation upon this subject, decline a reconsideration of the bill.

The bill entitled, an act laying a tax on all lotteries which may be hereafter authorised by the laws of this state, was read the second time and will not pass, sent to the house of delegates

by the clerk.

The bill entitled, an act to appoint Samuel Ogle, trustee for the sale of the real estate of Jo. seph Ogle, late of Frederick county deceased, was read the second time, passed with the proposed amendment, and sent to the house of delegates by the clerk.

Amendment proposed. Strike out the words "real estate" in the 5th line of the 2nd page and insert "said one hun. dred and five acres of land."

The senate proceeded agreeably to their resolution to the second reading of the bill entitled, an act to prohibit the collection of certain wharfages within the city of Baltimore, and the bill being read, the question as put, shall this bill pas? The year and nays being required appear. ed as follow:

The senate proceeded to the second reading by special order of the bill entitled, a supplement to the act entitled, an act to incorporate a company to make a turnpike road leading to Cumberland, and for the extension of the charters of the several hanks in the city of Baltimore, and for other purposes, and on progression in reading said bill, on motion of Mr. N. Williams, the

question was put, will the senate receive the following as an amendment, viz.

After the word "act" in the 11th section, strike out the following words, "and in case of the acceptance of and compliance with the provisions of this act, by the several banks hereby required to make the aforementioned road, the faith of the state is further solemnly piedged to the several existing banks in the city of Baltimore, not to grant a charter of incorporation to any other banking institution to be established in the city or precincts of Baltimore, before the first day of January, eighteen hundred and thirty five, and the end of the session of the General Assembly next thereafter? The yeas and nays being required, appeared as follow:

The senate met.—The clerk of the house of delegates delivers a bill entitled, an act to make public an old road in Frederick county, passed by that house, Jan. 26, 1814; a bill entitled, an act for the relief of Abner Neale, Francis Wills and John Cole, of the city of Baltimore; a bill en-V titled, an act to fix and regulate the quality of silver plate manufactured or sold or offered for sale in the city of Baltimore, and for other purposes; a bill entitled, an act to open a road from Richard Owing's Mill to Elk Ridge Church, in Queen Caroline Parish, in Anne Arundel county, and to repeal the acts of assembly therein mentioned; a bill entitled, an act to incorporate the Washing. ton Blanket and Woolen Manufacturing Company of Prince George's county; a bill entitled, an act to incorporate a Charitable Society in the Town of Easton, and a bill entitled, an act to confirm an act entitled, an act to alter, change and repeal all such parts of the constitution and form of government of this state as relate to the division of Prince George's county into election districts, severally passed by that house, Jan. 27, 1814; which were severally read the first time and ordered to lie on the table. Also returns the bill entitled, an act extending the benefit of the insolvent laws to certain petitioners therein mentioned, passed by that house, Jan. 27, 1814; ordered to be engrossed. Also returns the bill entitled, an act authorising a lottery to raise a sum of money for certain purposes therein mentioned, and a bill entitled, an act to authorise a lottery for finishing and completing the Protestant Episcopal Church in Frederick-Town, with the following messa ge: BY THE HOUSE OF DELEGATES, Jan. 27, 1814
