

M'Kinsey, a sum of money equal to the half pay of a drummer; to Solomon Bernott, a sum of money equal to the half pay of a fifer; and to Solomon Summers, a sum equal to the half pay of a private, or to their respective orders each, a sum of money annually in quarterly payments, as a further remuneration for the services rendered their country during the American war.

*Provided always*, That the above remuneration is in lieu of, and not in addition to any sum of money which any of the aforementioned persons have heretofore been authorised to receive from the state of Maryland for the aforesaid services: *And provided also*, That if any of the herein named persons receive half pay from the United States, they shall not be entitled to receive the remuneration herein before provided for them.

Also returns the bill entitled, an act to authorise the justices of the levy court and orphan's court of Charles county to grant permits to retailers of spirituous liquors and ordinary keepers in certain cases; the bill entitled, an act for building a bridge over North East Creek in Cecil county; and the bill entitled, an act to establish a bank and incorporate a company to be styled the Bank of Westminster, severally endorsed, "by the house of delegates Jan. 31, 1814;" read the second time and will not pass. Also returns the resolution relative to a new edition of the constitution of this state, dissented from by that house Jan. 31, 1814.

The senate met. The bill entitled, an act declaratory of the law on returns to writs of habeas corpus and for the better protection of the liberty of the citizen, was read the second time by special order, passed and sent to the house of delegates by the clerk.

The bill entitled, an act for turnpiking the road from Baltimore to Belle-Air, and thence to the site fixed upon for a bridge over the river Susquehanna near Rock Run; and the bill entitled, an act to incorporate a company to make a turnpike road from the turnpike near Westminster to Taney-Town, thence with the main street through Emmitsburg to Troup's tavern, were severally read the second time, passed and sent to the house of delegates by the clerk.

The bill entitled, an act relating to dogs in Allegany county, was read the second time and will not pass, sent to the house of delegates by the clerk.

The bill entitled, a supplement to the act entitled, an act to reduce into one the several acts of Assembly respecting elections, and to regulate said elections; and the bill entitled, an act for the relief of Parlemon Spencer of Queen Ann's county, were severally read the second time by special order and will not pass, sent to the house of delegates by the clerk.

The bill entitled, an act to authorise and empower the levy court of Talbot county to assess and levy a sum of money for the purposes therein mentioned; and the bill entitled, an act to repeal an act entitled, an act for extending Green street in the city of Baltimore were severally read the second time, passed with certain amendments and sent to the house of delegates by the clerk.

On motion the question was put, will the senate reconsider their amendment to the bill entitled, a further supplement to the act entitled, an act for opening and extending Aisquith street in the eastern precincts of Baltimore? Determined in the negative and the bill with the following message sent to the house of delegates by the clerk.
