The committee in making the report which they feel it their duty to do, regret very much the great loss which John Lucas will sustain in the diminished value of his property, especially as he has uniformly manifested an anxious wish to prevent the necessity of recurring to legislative aid by contracting on terms advantageous to the claimant of the reversionary interest.
