

Mr. J. Thomas delivers a petition from sundry inhabitants of Frederick county, praying a turnpike road from Emmitsburg to intersect the turnpike from Westminster to Hagers town. Which was read and referred to Messrs J. Thomas, Howard and J. H. Thomas.

Mr. Howard delivers a petition from Elizabeth Reid, of Frederick county, praying that she may be authorised to hold certain lands. Which was read and referred to Messrs. Howard, J. H. Thomas and Taney.

Mr. B. Hands from the committee delivers the following report :

The committee to whom was referred the petition of John Glanville, of Kent county, report, that they have taken the same into consideration and find the facts therein stated to be true ; they therefore recommend the following resolution :

Resolved, That the treasurer of the Western Shore be, and he is hereby authorised and directed to pay to John Glanville, of Kent county, a private in the twenty first regiment of militia, or his order, the sum of one hundred and fifty dollars, in consideration of the loss of his labor and expenses incurred by him, in consequence of a wound received while in actual service

Which was read the first and second time by special order, and the resolution therein contained assented to, and sent to the senate.

The bill entitled, an act for the benefit of the heirs of George N. Ford, late of Charles county, deceased, was read the second time, passed, and sent to the senate.

The bill entitled, a supplement to the act entitled, an act to incorporate a bank to be called by the name of the Farmers' Bank of Somerset and Worcester, was read the second time, passed and sent to the senate.

The amendments proposed by the senate to the bill entitled, an act to lay out and make public a road in Queen Ann's county, were read the second time, assented to and the bill ordered to be engrossed.

On motion by Mr Van Horn, Ordered, that the committee of claims allow on the journal of accounts to such members of the Legislature from the Eastern Shore as were obliged by reason of the difficulty and danger of crossing the bay, to incur extraordinary expense in passing round the head of the bay, such sum as they may think reasonable to reimburse such expense.

The clerk of the senate delivers the bill entitled, an act authorising the sale of a lot of ground in the city of Baltimore, owned by the children of John Sherlock, deceased, endorsed, "will pass." The bill entitled, an act to make valid a deed therein mentioned, endorsed, "will pass." Ordered to be engrossed. The bill entitled, an act to reinstate in the county court of Alleghany county, the proceedings of a case therein mentioned. The bill entitled, an act to change the place of holding the elections in the fourth election district in Alleghany county. The bill entitled, an act for the benefit of James Hopkins, of Queen Ann's county ; and the bill entitled, an act for the benefit of Robert Armstrong, of Alleghany county, severally endorsed, "will pass with the proposed amendments ;" which amendments were read, assented to, and the bills severally ordered to be engrossed.

Mr. Hogg delivers a remonstrance from sundry inhabitants of Cecil county, against the petition for a road in South Susquehanna hundred. Which was read and referred to the committee on the petition to which it is counter.

Mr. Mitchell delivers a petition from Samuel Miller, of Cecil county, counter to the petition of John Cameron, Which was read and referred to the committee on the petition to which it is counter.

Mr. Ford delivers a petition from William D. Harrison, and Thomas D Clagett, praying that a law may pass authorising the sale of certain lands held by them in common with certain infants. Which was read and referred to Messrs. Ford, Stonstreet and Neale.

Mr. Hambleton from the committee delivers the following report :

The committee to whom was referred the petition of Jacob Gibson, of Talbot county, report, that they have examined the account and vouchers accompanying the same, and beg leave to submit the following resolution :

Resolved, That the treasurer of the Western Shore be, and he is hereby directed to pay out of any unappropriated money in the treasury, to Jacob Gibson the sum of eighty four dollars and fifty cents, as a compensation for his trouble and expense in transporting two six pound cannon from Baltimore to Saint Michaels some time in the month of May, in the year eighteen hundred and thirteen.
