

Mr. M'Mahon from the committee, delivers a bill entitled, an act for the benefit of Sarah Payne, widow of John Payne, late of Alleghany county, deceased. Which was read the first and second time by special order, passed and sent to the senate.

The amendment proposed by the senate to the bill entitled, an act relating to the several banks within this state, was read the second time, and on motion by Mr. Dorsey, the question was put, that the house receive the words "and in like manner to the United States" as an amendment thereto? The yeas and nays being required, appeared as follow:

So it was determined in the negative.

The question was then put, that the house assent to the amendments proposed by the senate to the said bill? Resolved in the affirmative, and the bill ordered to be engrossed.

On motion by Mr. Dorsey, the question was put, that the house assent to the following resolution:

Resolved, That the several banks in this state, be and they are hereby authorised and empowered, to lend money to the United States, in the same manner that they are now authorised by law to make loans of money to the state of Maryland. The yeas and nays being required, appeared as follow:

So it was determined in the negative.

The speaker laid before the house a communication from the auditor of the state, enclosing a statement of all advances of money, made during the years 1813 and 1814, &c. pursuant to an order of this house of the 20th instant. Which was read and ordered to be printed.

Mr. Reynolds presented a petition from Jarred Catterton, of Calvert county, praying a law may pass, authorising the levy court of said county to levy on the assessable property of said county, a small sum of money to support himself and family. Which was read and referred to Messrs. Reynolds, Turner and Blake.

The engrossed bills from No. 31 to No. 54, inclusive, were read, assented to and sent to the senate.
