The bill entitled, an act relating to the judges of the several courts of this state, and the bill authorising the sale of Gabriel G. Van Horn's real property, with the message relating thereto, were sent to the senate.

The report on the petition of Zachariah Roberts was read the second time, concurred in, and the resolution therein contained assented to and sent to the senate.

The report on the memorial of the officers of the militia of the Eastern Shore, relative to the salary of the militia accountant for said shore, was read the second time, concurred in, and the resolution therein contained (being first amended by striking out "two hundred" and inserting "one hundred,") assented to and sent to the senate.

The report on the petition of John Jolly, was read the second time, concurred in, and the resolution therein contained assented to and sent to the senate.

Mr. M. Mahon from the committee delivers the following report :

The committee to whom was referred the petition of the inhabitants of Cumberland, in Alleghany county, praying an act of incorporation, beg leave to report, that they have had the same under consideration, and are of opinion that as the session is nearly at an end and an order having passed this house to close the journal of accounts before the petition came into their hands, and as your committee are totally ignorant what kind of an act of incorporation would be most agreeable to the citizens of said town: they would therefore recommend that a meeting of the citizens of Cumberland should be called as soon as convenient to appoint a committee to draft such a law as will meet the approbation of the citizens of said town in order to be laid before the general assembly at their next meeting.
