 5th. Strike out from the word "county" in the eighth line of the fifth page, to the word "till" in the ninth line of the same page.
 6th. Strike out from the word "Susquehanna" in the third line of the seventh enacting clause to the end of the line.
 7th. Strike out the words "through Charles Town" in the title of the bill. Sent to the house of delegates by the clerk.

The bill entitled, an act to open a road in Worcester county, was read the second time and will not pass, sent to the house of delegates by the clerk.

The bill entitled, an act for the benefit of Sarah Payne, widow of John Payne, late of Alleghany county, deceased, was read the second time, passed and sent to the house of delegates by the clerk. The senate adjourns until 5 o'clock, P. M.

The senate met.

The clerk of the house of delegates delivers a bill entitled, an act for the benefit of John Darnall contractor for the supply of the militia of Prince George's county, passed by that house January 25, 1815, and the following resolution:

BY THE HOUSE OF DELEGATES, January 25, 1815.

Whereas, the laws passed at December session, eighteen hundred and thirteen, as well as the votes and proceedings of that session that were intended for Saint Mary's, Charles and Montgomery counties, were destroyed by the enemy while at Upper Marlborough, in Prince George's county: Therefore,

Resolved, That the governor and council be, and they are hereby authorized and requested to procure and if necessary to have printed so many of the laws, votes and proceedings of that session, and forward the same to the clerks of the county court of said counties, as the said counties and the officers thereof were entitled to receive, and that the expense thereof be paid out of the treasury of the Western Shore, by a draught drawn on the treasurer by them for that purpose.

Also returns the resolutions relative to printing the laws, votes and proceedings, &c. endorsed by the house of delegates January 25, 1815. Read the second time and dissented from.

On motion of Mr. N. Williams, Resolved, that the bill entitled, an act for the benefit of sheriffs and collectors, be postponed indefinitely.

The bill entitled, an act for the benefit of the Presbyterian congregation of Queen Ann's and Caroline counties, and the bill entitled, an act for the extension of streets in the city of Baltimore and for other purposes, were severally read the second time and will pass.

The bill entitled, an act to incorporate a company to make a turnpike road, from the turnpike road leading from Westminster through Harman's Gap to Hager's Town to Emmitsburg in Frederick county, was read the second time by special order and will pass.

Mr. Stephen presented a petition from Elizabeth Brewer, of the city of Annapolis, praying to be put on the pension list of her county. Which was read and referred to Messrs. Stephen, Fenwick and Holbrook to consider and report thereon.

THURSDAY, January 26.

The senate met. Present the same members as on yesterday. The proceedings of yesterday were read.

The bill entitled, an act for the benefit of the Presbyterian congregation of Queen Ann's and Caroline counties. The resolution in favor of John Brewer, was read the second time, assented to and sent to the house of delegates by the clerk.

The bill entitled, an act relinquishing the right of the state of Maryland in a tract of land called McLean's Recovery, in Baltimore county to George Grundy of the city of Baltimore, was read the second time, passed and sent to the house of delegates by the clerk.

The bill entitled, an act for the erection of a new gaol in Frederick county and for other purposes, was read the second time, passed and sent to the house of delegates by the clerk.

Mr. N. Williams from the committee delivers the following resolutions:

Whereas, by the 33d section of the constitution of this state, it is provided "that the governor by and with the advice and consent of the council, may embody the militia, and when so embodied shall alone have the direction thereof, and shall also have the direction of all the regular land and sea forces under the laws of this state, but he shall not command in person, unless advised thereto by the council, and then only so long as they shall approve thereof." And whereas, Levin Winder, Esquire, was chosen governor of this state in November 1812, for the ensuing year, and did accept the appointment, and qualify according to the constitution and law. And whereas, it appears by the proceedings of the council that an entry was made therein under date of the 20th of April, 1813, in the following words: "The council advised the governor to take command of the militia in person," unaccompanied by any reasons or explanations, the governor being then absent; but the
