The bill entitled, an act to secure the printing of the laws and votes and proceedings, and to require the faithful performance thereof by the printer to the state, was read the second time, passed and sent

the house of delegates by the clerk.

The bill entitled, an act granting a loan of money to the Levy court of Calvert county, was read the

second time by special order and will not pass; sent to the house of delegates by the clerk.

The clerk of the house of delegates delivers a bill entitled, an act to pay the civil list and other expenses of civil government for the year one thousand eight hundred and sixteen. A bill entitled, an act annulling the marriage of George Little and Mary his wife. A bill entitled, an act to revive and comtinue an act entitled, an act for the relief of Henry Howard, (of John,) of Montgomery county, severally passed by that house January 26, 1816. A bill entitled, an act authorising the sale of the real and personal estate therein mentioned, passed by that house January 27, 1816. Resolutions in favor of Emanuel Ebbs, Gassaway Watkins and Jonathan Tutwiller, revolutionary soldiers. Which were severally read the first time and ordered to lie on the table. Also returns the engrossed bills Nos. 92, 93, 94, 95, 147, 148, severally assented to by that house January 26, 1816.
