The senate met. The same members present as on yesterday, except Mr. Magruder. The proceedings

of yesterday were read. Mr. Winchester and Mr. Winder appeared in the senate.

The bill, entitled, An act to allow William Waller, late sheriff and collector of Somerset county, fur ther time to complete his collections, was read the second time and will pass with the proposed amend-

ments, and sent to the house of delegates by the clerk.

Amendments proposed. At the end of the bill add the two following sections: 1. " Be it enacted, That it shall be the duty of the said William Waller, before he proceeds to execute or distrain the property of any person or persons for taxes, public dues, or officers fees, in virtue of this act, to deliver to such person or persons chargeable with the same, at least thirty days previous to the levying such execution or distress, an account, written in words at full length, of the taxes, public dues, or officers fees, demanded of him, her or them, with an affidavit annexed thereto, that he hath not received any part thereof, nor anything in security or satisfaction for the same, more than credit given, to the best of his knowledge. 2. Be it enacted, That the said William Waller, before he derives any benefit from or under this act, shall lodge his collection books in the clerk's office of Somerset county, to be open for the inspection of all persons in terested therein."
