

The bill, entitled, A supplement to the act, entitled, An act to provide for the education of poor children in Kent, Talbot, Cecil, Anne-Arundel and Montgomery counties, was read the second time.

The bill, entitled, An act for the re-valuation of real and personal property, in the counties therein mentioned, was read the second, and by special order the third time, and will pass with the proposed amendment, and sent to the house of delegates by the clerk. Amendment proposed: after the word "counties" 9th line 1st section strike out to the end of the section.

The bill, entitled, An act to alter the time of the sitting of the several county courts in the Fourth judicial district, was read the second time.

The bill, entitled, An act for the relief of William Damsell, was read the second, and by special order the third time, and will not pass. Sent to the house of delegates by the clerk.

The bill, entitled, An act for straightening a road in Sassafras Neck, Cecil county, was sent to the house of delegates by the clerk.

Mr. Carmichael presented the petition of James Cudjo, Edward Cudjo, and Richard Cudjo, of Kent county; which was read and referred to Messrs. Carmichael, Winder and Hollyday, to consider and report thereon.

On motion of Mr. Winder, Leave given to bring in a bill, entitled, An act concerning the judgments and judicial proceedings of the courts of justice in this state, and to provide for the completion of the records in certain cases. Ordered, That Messrs. Winder, Carmichael and Taney, be a committee to prepare and bring in the same.

On motion of Mr. Taney, Leave given to bring in a bill, entitled, An act to regulate the proceedings in the chancery and county courts in the cases therein mentioned. Ordered, That Messrs. Taney, Gale and Dorsey, be a committee to prepare and bring in the same.

The bill, entitled, An act to authorise a lottery to raise a sum of money for completing the Severn church in Anne-Arundel county, was read the second time.

The bill, entitled, A supplement to the act, entitled, An act for the relief of Sarah Ellis and her children, of the city of Baltimore, was read the second time.

The bill, entitled, An act to confirm an act, entitled, An act to alter and change all and every part of the constitution and form of government as relates to the attorney-general, was made the order of the day for Friday the 16th January; and the bill, entitled, An act providing for the appointment of an attorney-general, and of districts attorneys in the several judicial districts of this state, and for Baltimore city court, made the order of the day for Friday the 16th January.

The bill, entitled, An act for the relief of Elizabeth League of the city of Baltimore, was read the third time, passed, and sent to the house of delegates by the clerk.

The bill, entitled, An act for the relief of Priscilla Nicholls of Montgomery county, the bill, entitled, An act relating to the town of Belle-Air, in Harford county, and the resolution in favour of Netley Maddox and his securities, were severally read the second time.

The bill, entitled, An act to incorporate the Patapsco Canal company, was on motion postponed for further consideration.

The bill, entitled, An act to provide for the conveyance and return of process issued from the courts of one county to the officers of another, was read the second time.

The clerk of the house of delegates delivers the following bills: a bill, entitled, An act for the relief of sundry poor out-pensioners of Anne-Arundel county; a bill, entitled, An act to authorise Turbutt R. Betton, of Queen-Anne's county, to remove certain negro slaves from Fairfax county, Virginia, into this state; a bill, entitled, An act authorising a lottery to raise a sum of money for the purpose of building a Masonic Hall at Church Hill in Queen-Anne's county; a bill, entitled, An act extending the benefit of the insolvent laws to Junius W. Moore of Montgomery county; a bill, entitled, An act to incorporate the Roman Catholic Free School in the city of Baltimore; a bill, entitled, An additional supplement to the act, entitled, An act to incorporate a company for the purpose of building a bridge over the river Susquehanna; a bill, entitled, An act authorising a lottery or lotteries to raise a sum of money for building a Masonic Hall and Church in New-Market, Frederick county, severally passed by that house January 14, 1818. And a bill, entitled, An act to establish a bank and incorporate a company under the name of The Bank of Dorchester, passed by that house, January 13, 1818: And a resolution respecting the armory on the eastern shore; which were severally read the first time and ordered to lie on the table.

The senate met. Present the same members as on yesterday. The proceedings of yesterday were read.

Mr. Winder from the committee reported a bill, entitled, An act concerning the judgments and judicial proceedings of the courts of justice in this state, and to provide for the completion of the records in certain cases; which was read the first time and ordered to lie on the table.

The senate resumed the consideration of the bill, entitled, An act to establish and incorporate the Patapsco Canal Company; the bill being read throughout, the question was put, Shall this bill pass? Determined in the affirmative; and sent to the house of delegates by the clerk.

The bill, entitled, An act for the relief of Elizabeth Sterrett of Washington county, the bill, entitled, An act declaring what shall be evidence in certain cases therein mentioned; the bill, entitled, An act to alter such parts of the declaration of rights, the constitution and form of government, as relates to the administration of oaths in certain cases. The bill, entitled, An act enlarging the powers of the trustees of the poor of Harford county; the bill, entitled, An act to provide for the erection of a new jail in Hagers Town, Washington county; the bill, entitled, An act for the benefit of John K. Rowe and Richard Bevan of Baltimore county, were severally read the second time.

Agreeably to the order of the day, the senate proceeded to the second reading of the bill, entitled, An act to alter and change such parts of the constitution and form of government as provide for the election of the council, and the manner and time of electing the governor; the bill being read throughout, was on motion ordered to be engrossed for a third reading.
