incorporate the frustees of the Bladensburg Academy, and for other purposes; a bill, entitled, An act to incorporate the German Society of Maryland; a bill, entitled, An act to incorporate the Grand Lodge of free and accepted masons of Maryland; which were severally read the first time and ordered to lie on the table. And returns the bill, entitled, An act to provide for the opening and extension of Pratt-street in the city of Baltimore, and the bill, entitled, An act to establish an incorporate the Patapsco Canal Company, severally endorsed by that house, "will pass with the proposed amendments;" which amendments were read the first time. And the bill, entitled, An additional supplement to the act, entitled, An act to establish a bank and incorporate a company under the name of The Bank of Caroline, endorsed by that house, "24th January, 1818; read the second time and will pass." Ordered to be engrossed. Also a resolution in favour of Robert Halkerson, of James Leonard, relative to runaway negroes, and relative to Brookville Academy; which were severally read the first time and ordered to lie on the table.

The senate, agreeable to order, resumed the further consideration of the bill, entitled, An act to alter and change such parts of the constitution and form of government as provide for the election of the council, and the manner and time of electing the governor; which was read the second, and by special order the third time, and the question being put, Shall this bill pass? The yeas and nays being required ap-

The bill, entitled, An act extending the time for taking the bond of the sheriff of Baltimore county, was read the first, and by special order the second and third time, passed, and sent to the house

of delegates by the clerk.

The senate resumed the consideration of the bill, entitled, An act providing for the appointment of an attorney general, and of d strict attorneys in the several judicial districts of this state, and for Baltimore city court; which was read the second time.

The resolution in favour of the Elkton Academy, was read the third time, assented to, and sent to the

house of delegates by the clerk.

The clerk of the house of delegates delivers the following resolutions: In favour of Leonard Swann, in favour of the messenger to the executive, requesting information from the honourable John L. Kerr, agent on behalf of the state, and a resolution relative to the colonization of the free people of colour; which were severally read the first time and ordered to lie on the table.
