county court of Queen-Anne's county to divide the real estate therein mentioned; a bill, entitled, A supplement to the act, entitled, An act to provide for the appointment of commissioners for the regulation and improvement of the town of Princess Anne, in Somerset county; a bill, entitled, An act authorising Jane Blake, o Kent county, an alien, to hold real property; a bill, entitled, An act to provide for building bridges over Patuxent river; a bill, entitled, An additional establish Pilots and regulate their tees; which were severally read the first time and ordered to lie on the table.

The bill, entitled, An act to confirm and make valid the title of James Cudjo, Edward Cudjo, and Richard Cudjo, of Kent county, to a certain lot of land therein mentioned, was read the second, and by

special order the third time, passed, and sent to the house of delegates by the clerk.

The bill, entitled, An act to incorporate the German Society of Maryland, and the bill, entitled, An act to provide for the extending of Lombard-street in the city of Baltimore, were severally read the second time.

The bil' entitled, An act for the relief of Elizabeth League of the city of Baltimore, was returned by the house of delegates, endorsed "January 29, 1818; read the second time and will pass." Ordered to be engrossed.

The bill, entitled, An act for the benefit of Elizabeth Johnson of the city of Baltimore, was read the third time, and the question put, Shall this bill pass? The year and nays being required appeared as fol-

Ordered, That Messrs. Calvert, Hollyday and Gale, be a committee to prepare and bring in the same. The bill, entitled, An act authorising the levy court of Somerset county to levy and assess a sum of

money for ce tain purposes therein mentioned, was read the second, and by special order the third time,

passed, and sent to the house of delegates by the clerk.

On motion of Mr. W nder, Leave given to bring in a bill, entitled, A supplement to an act, entitled, An act for the clief of Elizabeth R. Snyder of the city of Baltimore. Ordered, That Messrs. Winder, Carmichael and Gale, be a committee to prepare and bring in the same.

Mr Winder reported said bill; which was read the first time and ordered to lie on the table.

The bill, entitled, An act for the relief of the poor of Caroline county, was read the third time, passed

with sundry amendments, and sent to the house of delegates by the clerk.

The bill, entitled, An act for the relief of Matilda Mercer, Stephen F Donaldson, and Priscilla Donaldson, of the city of Baltimore, was read the third time and will not pass. Sent to the house of delegates by the clerk.

Mr. Gale from the committee reported a bill, entitled, An act to regulate the manner of obtaining and

altering public roads in this state; which was read the first time and ordered to lie on the table.

The bill, entitled, An act to appoint a warden for the gaol of Baltimore county, was read the third

time, passed, and sent to the house of delegates by the clerk.

The bill, entitled, An act to provide for the removal of lunatic paupers from the several counties of this state to the hospital in Baltimore, was read the second, and by special order the third time, passed with amendments, and sent to the house of delegates by the clerk.

The resolution relative to the armoury on the eastern shore was read the second, and by special order the third time, assented to, and sent to the house of delegates.

The clerk of the house of delegates delivers the following bills: a bill, entitled, An additional supplement to the act, entitled, An act for the relief of sundry insolvent debtors passed November session eighteen hundred and five; which was read the first time and ordered to lie on the table; the bill, entitled, An act to authorise the guardians of Henry Hammond, an infant, to apply the proceeds of property for the purpose therein mentioned, passed by the house of delegates January 24th 1818; which was read the second, and by special order the third time, passed, and sent to the house of delegates by the clerk. by special order, passed, and sent to the house of delegates by the clerk.

The bill, entitled, An act respecting the Susquehanna Canal, together with the substitute reported by the committee to whom the same was referred, was read the third time, and on the question being put, Shall this bill pass? Determined in the negative.

The question was then put. Will the senate concur in the report of the committee on the said bill? Determined in the affirmative, and the substitute adopted, and sent to the house of delegates with the follow-

BY THE SENATE, January 30, 1818.

Gentlemen of the House of Delegates,

We have rejected the bill which originated in your house, entitled, An act respecting the Susquehanna Canal, and have passed a new bill instead thereof, which is herewith transmitted for your concurrence. A memorial counter to the bill which came from your house was laid before the senate, and in consequence thereof the bill was referred to a committee, who by the consent of the original petitioners, and the counter memorialists, reported the bill now transmitted to your house.
