

The clerk of the house of delegates delivers the following bills: a bill, entitled, An act relating to the collection of the public arms; a bill, entitled, A supplement to the act, entitled, An act authorising a lottery for raising a sum of money for the purposes therein mentioned, passed at November session eighteen hundred and ten; a bill, entitled, An act for the relief of the heirs of Lawrence O'Neal; a bill, entitled, An act for the founding a college in the city or precincts of Baltimore by the name of Asbury College; a bill, entitled, An act relating to turnpike roads; a bill, entitled, An act to empower the judges of the county court of Allegany county to reinstate the cause of John Hoblitzell, and others, against Martin Rizer, of Matthias; a bill, entitled, An act for the relief of Christian Hager; which were severally read the first time and ordered to lie on the table. And returns the bill, entitled, An act to confirm and make valid the title of James Cudjo, Edward Cudjo, and Richard Cudjo, of Kent county, to a certain lot of land therein mentioned; and the bill, entitled, An act concerning the judgments and judicial proceedings of the courts of justice in this state, and to provide for the completion of the records in certain cases, severally endorsed, "will pass." Ordered to be engrossed.

The bill, entitled, An act to make valid a deed from William Mure, formerly of Saint Mary's county, to John Maddox of Saint Mary's county, was read the second, and by special order the third time, and will not pass. Sent to the house of delegates by the clerk.

The bill, entitled, An act for establishing and building a bridge over Monocacy river in the county of Frederick, was read the third time and will pass with the proposed amendments, and sent to the house of delegates by the clerk.

The bill, entitled, An act for the relief of sundry poor out-pensioners of Anne-Arundel county, was read the third time, passed, and sent to the house of delegates by the clerk.

On motion of Mr Dorsey, Leave given to bring in a bill, entitled, A supplement to the act, entitled, An act regulating the inspection of salted fish, passed at the present session of the general assembly of Maryland. Ordered, That Messrs. Dorsey, Maxcy and Calvert, be a committee to prepare and bring in the same.

The bill, entitled, An act for the relief of Henry Nyman of Washington county, was read the third time and will not pass.

The bill, entitled, An act for the relief of Catharine Freshour of Frederick county, was read the second, and by special order the third time, and will pass. Sent to the house of delegates by the clerk.

The bill, entitled, A supplement to the act, entitled, An act directing the manner of suing out attachments in this province, and limiting the extent of them, was read the second and third time by special order, passed, and sent to the house of delegates by the clerk.

The bill, entitled, An act to authorise Sarah Harry, of Washington county, to sell and convey certain property therein mentioned, was read the third time and will not pass. Sent to the house of delegates by the clerk.

The clerk of the house of delegates delivers the following resolutions: In favour of Bean S. Pigman, executor of Hanson Briscoe, and a resolution repealing a resolution passed in the year 1814, relative to the executors of James Earle; which were severally read the first time and ordered to lie on the table.

The senate adjourns until to-morrow morning 10 o'clock.

THURSDAY, February 5, 1818.

The senate met. Present the same members as on yesterday, except Mr. Winchester. The proceedings of yesterday were read.

The bill, entitled, An act to empower the judges of the county court of Allegany county to reinstate the cause of John Hoblitzell, and others, against Martin Rizer, of Matthias, was read the second, and by special order the third time, and will not pass.

The bill, entitled, An act to incorporate the Grand Lodge of Free and Accepted Masons of Maryland, was read the second, and by special order the third time, and on motion of Mr. Carmichael to strike out the first section, the question was put, Will the senate agree to strike out the first section? The yeas and nays being required appeared as follow:

AFFIRMATIVE.

So it was determined in the affirmative.

The question was then put, Shall this bill pass? Determined in the negative, and the bill sent to the house of delegates by the clerk.

The bill, entitled, An act to regulate lotteries, was read the second, and by special order the third time, and on motion of Mr. Gale to amend the bill by inserting therein "The Maryland Hospital Lottery," it was determined in the negative.

On motion of Mr. Hollyday to strike out the whole of the proviso? Determined in the affirmative.

On motion the further consideration thereof was postponed.

The bill, entitled, An act to authorise and empower Charles Robinson and Elizabeth Robinson, administrators of Thomas Robinson, of Anne-Arundel county, deceased, to convey certain lands therein mentioned, was read the second, and by special order the third time, and will pass with the proposed amendment, and sent to the house of delegates by the clerk.

Mr. Gale from the committee reported a bill, entitled, An additional supplement to the act, entitled, An act to establish a market at Bridge Town in Kent county, and for other purposes therein mentioned, and also to change the name of said place to Millington, was read the first, second and third time, by special order, passed, and sent to the house of delegates by the clerk.

Mr. Dorsey from the committee reported a bill, entitled, A supplement to an act, entitled, An act to regulate the inspection of salted fish; which was read the first, second and third time by special order, passed, and sent to the house of delegates by the clerk.
