

Mr. Gale then moved to reconsider the same? Determined in the negative.

Mr. Winchester then moved to insert the following proviso: "provided, that no such petition shall be presented to the said county courts, without the consent of a majority of the stockholders to be had at a meeting called for that purpose, or which meeting three weeks notice shall be given in at least two newspapers printed in this state?" Determined in the affirmative.

Mr. Taney moved to strike out the amendment proposed by Mr. Gale, for giving two months notice in the newspapers of the intended application? Determined in the affirmative.

Mr. Gale then moved the following amendment: At the end of the 7th section, insert the words "in payment whereof they shall nevertheless receive the notes issued by said bank, in all cases where said notes shall be offered?" Determined in the affirmative.

In progression in reading, Mr. Taney moved to insert before Mr. Gale's last amendment, "and in all actions of assumpsit brought by such assignees, by virtue of such assignment, it shall be sufficient for them to declare for so much money had and received to their use, and on such form of proceeding may give the special matter in evidence?" Determined in the affirmative.

In progression in reading, Mr. Gale moved to strike out the eleventh section? Determined in the negative.

Mr. Taney then moved to strike out the eleventh section? Determined in the affirmative. He then moved to insert in lieu thereof, the following section: "And be it enacted, that the assignees aforesaid shall have full power to prosecute any suit or suits at law or equity, for any fraudulent misapplication of the funds of the said bank against any person or persons by whom such fraudulent misapplication shall have been made, or who shall have fraudulently assented thereto, or against the legal representatives of such person or persons?" Determined in the affirmative.

Mr. Gale then moved to amend the amendment by inserting the words, "making such fraudulent misapplication" Determined in the negative.

In progression in reading, Mr. Jackson moved to strike out the word "five." Determined in the affirmative. He then moved to insert the word "ten?" Determined in the negative. It was then moved to insert "seven and an half?" Determined in the affirmative.

Mr. Taney moved that the following section be added to the bill: "And be it enacted, that all such parts of the charters of any banks heretofore incorporated by any law of this state, inconsistent with, or repugnant to, the provisions of this law, be and the same is hereby repealed?" Determined in the affirmative.

The clerk of the house of delegates delivers the following message:

BY THE HOUSE OF DELEGATES, Jan. 20, 1819.

Gentlemen of the Senate,

We received a message from your body on the 10th of December last, proposing to go into the election of a register of wills for Harford county, and putting in nomination Thomas S. Bond. Samuel Bradford is put in nomination by this house, in addition to the gentleman named in your message.

And the following bills: A bill, entitled, An act for the further compensation of jurors in Harford county; a bill, entitled, An act to repeal the act, entitled, An act for the encouragement of such persons as will undertake to build water mills; a bill, entitled, An act for the benefit of Rachel Weems of Anne-Arundel county; a bill, entitled, An act for the relief of James Simpson, of Frederick county; and a bill, entitled, A supplement to an act for the relief of the poor of Kent county; which were severally read the first time and ordered to lie on the table.

FRIDAY, January 22, 1819.

The senate met. Present the same members as on yesterday. The proceedings of yesterday were read. On motion of Mr. Winder, the additional rule of the senate was read a second time and adopted.

The following message was read, agreed to, and sent to the house of delegates by the clerk.

BY THE SENATE, January 22, 1819.

Gentlemen of the House of Delegates,

We agree to proceed to the election of a register of wills for Harford county this day at 12 o'clock, as proposed by you in your message of yesterday. No person is put in nomination by the senate in addition to those named by your honourable house. We have appointed Messrs. Emerson and Carmichael to join the gentlemen named on the part of your house to examine and count the ballots.

On motion of Mr. Gale, the senate proceeded to the election of a director in the bank of Baltimore.—The ballots being deposited in the ballot box, on examination thereof it appeared, that Joseph Sterrett was duly elected a director on the part of this state in the bank of Baltimore.

The bill, entitled, An act to incorporate a company to erect a toll bridge across the Potomac river opposite Shepherd's town, and the resolution relative to the compilation of the laws, were read the second time.

On motion, the senate proceeded to the election of a register of wills for Harford county. The ballot box being prepared, the ballots were deposited therein, sealed up, and delivered to the committee of the senate appointed to meet the committee appointed by the house of delegates, who retired to the conference room, and after some time returned and reported, that Thomas S. Bond was duly elected. Whereupon it is declared in the senate, that Thomas S. Bond be recommended by the senate to be commissioned by the governor as register of wills for Harford county.

The senate adjourns until to-morrow morning 10 o'clock.

SATURDAY, January 23, 1819.
