The clerk of the house of delegates delivers the following bills: A bill, entitled, An act further to continue an act passed at November session 1795, entitled, An act to incorporate an insurance company in Baltimore town; and a bill, entitled, A-further supplement to the act, entitled, An act for the distribution of a certain fund for the purpose of establishing free schools in the several counties therein named; which were read the first time and ordered to lie on the table.

The senate adjourns un til Monday morning 10 o'clock.

MONDAY, December 27, 1819.

Appeared in the senate chamber, Mr. Spencer, President, Mr. Jackson and Mr. Parnham, who adjourn until to-morrow morning 10 o'clock.

TUESDAY, December 28, 1819.

The same members as on yesterday Mr. Emerson, Mr. Gale and Mr. Howard, appeared, who adjourn until to-morrow morning 10 o'clock.

WEDNESDAY, December 29, 1819.

The same members as on yesterday. Mr. Carmichael, Mr. Cresap and Mr. Maxcy, appeared. The proceedings from Friday 24th inclusive, were read.

The bill ceding to the United States certain sites for the purposes therein mentioned, was read the

second time and laid on the table.

The bill further to continue an act passed at November session 1795, entitled, An act to incorporate

an Insurance Company in Baltimore town, was read the second time and laid on the table.

The bill to incorporate the trustees of the Federal Hill Sunday School, was read the second time, and on progression in reading the same the third time, on motion of Mr. Carmichael, to strike out the preamble, the question was put, Will the senate strike out as proposed? Determined in the negative.

On furthen progression, Mr. Carmichael moved to strike out the fifth section; the question being put, Will the senate strike out the fifth section? The year and nays being required appeared as follow:

Messrs. Carmichael and Jackson-2. Determined in the agirmative.

The senate adjourns until to-morrow morning 10 o'clock.

THURSDAY, December 30, 1819.

The senate met. Present the same members as on yesterday. The proceedings of yesterday were read. On motion, Resolved, That the executive communication of the 23d inst. covering the annual report of the inspectors of the Maryland Penifentiary for the present year, be referred to the consideration of the house of delegates.
