On motion of Mr. Gale, the bill to repeal the fourth section of an act passed at December session eighteen hundred and seventeen, entitled, An additional supplement to the act for the relief of sundry insolvent debtors, passed November session eighteen hundred and five, was referred to a special committee. Ordered, That Messrs. Gale, Howard and Parnham, be the said committee.

On motion of Mr. Carmichael, the bill to open and extend East street in the city of Annapolis, and to close up that part of said street leading to Prince George street, was referred to a special committee. Ordered, That Messrs. Carmichael, Maxcy and Gale, be the said committee.

The bill to empower the county court of Queen Anne's county to divide the real estate therein mentioned, was read the second, and by special order the third time, and will pass.

The bill to incorporate the Franklin Beneficial Society, was read the second, and by special order the third time, when on motion of Mr. Gale, the question was put, Will the senate receive the following as an amendment?

Amendment. At the end of the bill add, "And be it enacted, That this act shall be and remain in force until the first day of January eighteen hundred and thirty-nine, and until the end of the next session of the general assembly which shall happen thereafter." Resolved in the affirmative.

The question was then put, Shall the said bill as amended pass? Determined in the affirmative.

The bill to incorporate the Baltimore Friendly Society, was read the second, and by special order the third time, when on motion of Mr. Gale, the question was put, Will the senate receive the following as an amendment to said bill?

Amendment. At the end of the bill add, "And be it enacted, That this act shall be and remain in force until the first day of January eighteen hundred and thirty-nine, and until the end of the next session of the general assembly which shall happen thereafter." Resolved in the affirmative.

The question was then put, Shall the said bill as amended pass? Determined in the affirmative.

The bill to incorporate the Jackson Beneficial Society of Baltimore, was read the second, and by special order the third time, when on motion of Mr. Howard, the question was put, Will the senate receive the following as amendments to the said bill?

Amendments. 1st. After the word "society" 5th line 3d section insert the words "shall pay and." 2d. At the end of the bill add "And be it enacted, That this act shall be and remain in force until the first day of January eighteen hundred and thirty-nine, and until the end of the next session of the general assembly which shall happen thereafter." Resolved in the affirmative.

The question was then put, Shall the said bill as amended pass? Determined in the affirmative.

On motion of Mr. Maxcy, Leave given to bring in a bill, entitled, An act to incorporate a company to erect a bridge over South river. Ordered, That Messrs. Maxcy, Gale and Parnham, be a committee to prepare and bring in the same.
