

The bill for the relief of James Earengay of Washington county, was read the second, and by special order the third time, and will not pass.

The further supplement to an act, entitled, An act to regulate the inspection of tobacco, was read the second, and by special order the third time, and will pass with the proposed amendments.

1. In 12th line 1st section after the words "same in" strike out the words "any note and manifest" and insert the words "all notes and manifests." 2d. In the 14th line 1st section after the words "cause the" strike out the word "sum" and insert the words "name of the state or territory wherein the same may have been given." 3d. In same line after the words "branded or" strike out the words "some one of the" and insert the word "three." 4th. In 15th line 1st section add to the word "parts" the letter "s." 5th. Strike out the 4th and 5th sections.

The bill to authorise John Cole, late sheriff and collector of Saint-Mary's county, to complete his collections, was read the second, and by special order the third time and will pass.

The bill for the relief of Susanna Teas of Washington county, was read the second, and by special order the third time, and postponed for further consideration.

Mr. Harper from the committee reported a bill, entitled, An act relating to voting by proxies in the banks of this state; which was read the first, and by special order the second and third time, and will pass.

The senate proceeded agreeably to their resolution, to the second reading of the bill, entitled, A supplement to an act, entitled, An act for the benefit of the University of Maryland; and the same being read a second, and by special order the third time, the question put, Shall the said bill pass? The yeas and nays being required appeared as follow:

Mr. Hollyday from the committee reported the said bill; which was read the first time and ordered to lie on the table.

On motion of Mr. Harper, Leave given to bring in a bill, entitled, An act supplementary to the act, entitled, An act to authorise a lottery or lotteries in the city of Baltimore. Ordered, That Messrs. Harper, Howard and Hollyday, be a committee to prepare and bring in the same.

Mr. Harper from the committee reported the said bill; which was read the first time and ordered to lie on the table.

The clerk of the house of delegates delivered the bill, entitled, An act for the relief of Henry Ellis of Saint-Mary's county; the bill, entitled, A supplement to the act, entitled, An act to regulate the manner of obtaining and altering public roads in this state; the bill, entitled, An act to provide for the erection of an additional wharf in the town of Nottingham in Prince-George's county, and for other purposes; and the bill, entitled, A supplement to an act entitled, An act for the distribution of a certain fund for the purpose of establishing free schools in the several counties therein named; which were read the first time and ordered to lie on the table.

And returns the bill to incorporate a company to erect a bridge over South river endorsed "will pass." Ordered to be engrossed. Also returns the bill to erect a new bridge over Great Choptank River in Caroline county, endorsed "will pass with the proposed amendments;" which were read the first time and ordered to lie on the table.

The bill further supplementary to the act, entitled, An act for amending and reducing into system the laws and regulations concerning last wills and testaments, the duties of executors, administrators and guardians, and the rights of orphans and other representatives of deceased persons, was read the second time and laid on the table.
