The senate have received your amendments accompanying the bill, entitled, A supplement to an act, entitled, Au act to repeal all such parts of the laws of this state as authorise the courts of law to sentence negro or mulatto slaves to undergo a confinement in the penitentiary. The senate think that the first amendment proposed by you unnecessary. The title of the act to which this is a supplement, embraces free negroes and mulattoes, but the enacting clauses do not. We think that the law would be more explicit without this amendment, and hope you will recede from it. The second amendment if made to correspond with the lines of the engrossed instead of the printed bill, as well as the other amendments, will meet with the concurrence of the senate.
