SATURDAY, January 20, 1821.

The senate met. Present the same members as on yesterday, except Mr. Carroll. The proceedings of yesterday were read.

The bill authorising Letitia Rochester to convey the lands therein mentioned, and for other purposes; the bill to encourage the destruction of crows in Kent county; and the bill to alter such parts of the constitution and form of government as relate to the council and to the appointment of certain officers, were sent to the house of delegates.

The bill to make valid a deed from Daniel Carroll to Thomas Simpson, was read the third time and will pass. Sent to the house of delegates.

The bill to allow Daniel Schnebly, late sheriff and collector of Washington county, further time to complete his collections, was read the second, and by special order the third time, and will not pass. Sent to the house of delegates.

The bill to provide for the building a court house in Anne-Arundel county, was read the third time and will pass. Sent to the house of delegates.

Mr. Carmichael from the committee to whom was referred the supplement to an act, entitled, An act to incorporate the Roman Catholic congregation in Baltimore town, reports the same with sundry amendments; which was read the third time and will pass with the proposed amendments.

Amendments proposed. 1 In 2nd page 4th line strike out the words "three hundred" and insert "one hundred." 2 After the word "manner" 1st line 3rd page strike out the words "hereinafter provided" and insert "to be provided by the pastors and trustees aforesaid." 3 Strike out the 3rd sec 4 Strike out the words "as is herein before provided" 2nd line 4th page and insert "as the pastors and trustees shall order and direct." Sent to the house of delegates.

The further supplement to the act, entitled, An act for regulating the mode of staying executions, and for other purposes, was sent to the house of delegates with the following message:
