Resolved by the General Assembly of Marvland, That they do concur in the resolution of the general assembly of Vermont, heretofore communicated to this general assembly, recommending the adoption of an amendment of the constitution of the Unit. d States, for the purpose of establishing an uniform mode of choosing representatives in the congress of the United States, and of electors of President and Vice-President, in the following words, to wit: Resolved by the General Assembly of the State of Vermont, That for the purpose of choosing representatives in the congress of the United States, each state shall, by its legislature, he divided into a number of districts equal to the number of representatives to which such state may be entitled; the districts shall be formed of contiguous territory, and contain, as nearly as may be, an equal number of inhabitants, entitled by the constitution to be represented: in each district, the qualified voters shall elect one representative, and no more.
