Kenzie; a resolution in favour of Thomas Wright and others; a bill, entitled, An act to ratify the proceedings of the commissioners appointed by Dorchester county court to make division of the lands and tenements of Doctor Daniel Sullivan, late of the same county, deceased; a bill, entitled, An act for the benefit of Mary Young, Henry W. Fitzhugh, and Elizabeth Dickens, of the city of Baltimore; a bill, entitled, An act to authorise a lottery to raise a sum of money for the purpose of building a church for the use of the Lutherans and Presbyterians in the neighbourhood of Allguiers in Baltimore county; a bill, entitled, An act for the benefit of John Barnes, clerk of Charles county; and a bill, entitled, An act to repeal the several acts of assembly respecting the herding of cattle in Allegany county; which were read the first time and laid on the table. And returns the bill for the benefit of the Baltimore Exchange Company, endorsed "will pass." Ordered to be engrossed. Also returns the bill for the relief of Sarah Cahall, of Caroline county, endorsed, "will not pass;" which with the following message, was sent back to the house of delegates:

On motion of Mr. Emerson, the senate proceeded to the election of a director for the state in the Bank of Baltimore; the ballot box being prepared, and the ballots deposited therein, on examination it appeared that James Harwood was unanimously elected. Whereupon it is declared in the senate, that James Harwood is unanimously elected as director on the part of the state for the Bank of Baltimore.

The resolution in favour of Thomas Wright, and others, was read the second time by special order and

laid on the table.

The senate resumed the consideration of the bill to amend and reduce into one system the laws to direct descents, and on motion of, Mr. Taney to strike out in the 9th sec. the words othen in the said court, and before the expiration of the term next succeeding that in which the return of the commissioners shall have been confirmed, the eldest son, child or person entitled, if of age, snall have election to take the whole estate, and pay to the others their just proportions of the value in money; and if the eldest child or person entitled refuses to take the estate, and pay to the others money for their proportions, then the next eldest child or person entitled, being of age, shall have the same election, and so on to the youngest child or person entitled, and if all refuse." The question was put, Will the senate strike out as proposed? The yeas and nays being required appear as follow:
