second, and by special order the third time, and will not pass. Sent to the house of delegates. The bill to incorporate the trustees of the Union Chapel of Harford county, was read the third time

and will pass. Sent to the house of delegates.

The bill respecting the assent of creditors to the release of debtors under the insolvent laws of this state, was read the second and third time by special order and will pass with the proposed amendment. Amendment proposed: "And be it enacted, That so much of the fourth section of the act, entitled, A further additional supplement to the act, entitled, An act for the relief of sundry insolvent debtors, passed at November session 1812, as requires an insolvent debtor to pay over or convey to his trustee or trustees sufficient in amount to pay fifty per cent. of his debts at the time of his second application, and also so much of the said section as requires the insolvent debtor, before he shall obtain a final release a third time, to pay over or convey to his trustee or trustees, estate sufficient in amount to pay seventy-five per cent. of his debts at the time of his third application, be and the same are hereby repealed."
