Mr. Carmichael from the committee reports a bill, entitled, An act to authorise the clerk of Anne-Arundel county to record a deed of manumission; which was read the first time and laid on the table.

The supplement to an act, entitled, An act to prevent the issuing of small bank notes, was read the second time and referred to Messrs. Taney, Carmichael and Harper.

The bill for the relief of Cornelius Seaman, of Washington county, was read the second and third time

by special order and will not pass.

The bill to extend the powers of the levy court of Baltimore county in the case therein mentioned,

was read the second, and by special order the third time, and will pass.

Mr. Carmichael from the committee reports a bill, entitled, An act to confirm and explain an act of assembly passed at December session eighteen hundred and nineteen, entitled, An act to make valid a deed of manumission executed by Thomas Carter, of Queen Anne's county, deceased; which was read the first time and laid on the table.

The bill to annull the marriage of Samuel Taylor, and Jane Taylor his wife, of Worcester county,

was read the second and third time by special order and will not pass.

The bill for the benefit of John Barnes, clerk of Charles county, was read the second, and by special

order the third time, and will not pass.

The additional supplement to the act, entitled, An act concerning crimes and punishments, and to regulate the salary of the first keeper, clerk, agent, deputy keepers, and guards of the penitentiary, was read the second, and by special order the third time, and will not pass.

The bill to repeal the several acts of assembly respecting the herding of cattle in Allegany county,

was read the third time by sgecial order and will pass.

Mr Gale from the committee reports a bill, entitled, A further additional supplement to an act, entitled, An act to incorporate a company for erecting a bridge over Chester river at Chester-Town; which was read the first time and laid on the table.

The bill for the benefit of the Conococheague Bank in Williamsport, in Washington county, was read

the second and third time by special order and postponed for further consideration.

The hill to empower Thomas Chase, of Anne-Arundel county, to sell the property therein mentioned, was read the second and third time by special order and the question put, Shall the hill pass? The year and nays being required appeared as follow:

The senate met. Present the same members as on yesterday. The proceedings of yesterday were read. The bill to empower Thomas Chase, of Anne-Arundel county, to sell the property therein mentioned; the bill to repeal the several acts of assembly respecting the herding of cattle in Allegany county; the additional supplement to the act, entitled, An act concerning crimes and punishments, and to regulate the salary of the first keeper, clerk, agent, deputy keepers, and guards of the penitentiary; the bill respecting the assent of creditors to the release of debtors under the insolvent laws of this state; the bill for the benefit of John Barnes, clerk of Charles county; the bill to extend the powers of the levy court of Baltimore county in the case therein mentioned; the bill for the relief of Cornelius Seaman, of Washington county; and the bill to change and alter the name of William Heyser Quantrill, to that of Jesse Duncan Elliott Quantrill, were sent to the house of delegates.

Mr. Jackson from the committee reports a bill, entitled, An act for the benefit of the Bank of Somer-

set in Princess Ann, in Somerset county; which was read the first time and laid on the table.

The resolution relative to the establishment of an uniform mode of electing representatives in congress, and of appointing electors of the president and vice president of the United States, was read the seconditime, laid on the table, and ordered to a third reading on Friday 2nd February.

The further supplement to an act, entitled, An act relating to negroes, and to repeal the acts of as-

sembly therein mentioned, was read the second time and laid on the table.

Mr. Jackson from the committee reports a bill, entitled, A further additional supplement to the act, entitled, An act for regulating the mode of staying executions, and repealing the acts of assembly therein mentioned, and for other purposes, passed at Dec. session 1819; which was read the first time and laid on the table.

The clerk of the house of delegates delivers a bill, entitled, An act incorporating into one the several acts relating to constables fees; a bill, entitled, An act to lay out a road in Harford county, a bill, entitled, An act respecting certain roads in Prince George's county; and a bill, entitled, A further additional supplement to the act, entitled, An act relating to public roads in this state, and to repeal the acts of assembly therein mentioned; which were read the first time and laid on the table.

The senate resumed the consideration of the bill for the benefit of the Conococheague Bank, in Williamsport, in Washington county; which was read and will pass with the proposed amendment: Amendment proposed. At the end of the bill add "And be it enacted, That this act shall cease to have any effect should the said bank proceed to transact any other business than such as may be necessary to wind up the concerns of the same."

The bill for the benefit of Thomas B. Hall, of Washington county, was read the second, and by spe-

cial order the third time, and will pass with the proposed amendments.

Amendments proposed. 1. Strike out after the word "thereto" 7th line enacting clause to the word "provided" and insert "the said Thomas B. Hall shall produce the assent, according to law, of two thirds in value of his creditors, exclusive of the debt due from him to the United States; and provided also," 2 Insert the word "other" after the word "the" last line of the bill.

der and laid on the table.
