

The resolution relative to the school fund in Calvert county, was read the third time and dissented from.

Mr. Emerson submits the following resolution:

BY THE SENATE, Feb. 15, 1821.

Resolved by the general assembly of Maryland, That the commissioners of the school fund for Calvert county, be and they are hereby directed, to report to the next general assembly the amount of money received by them by virtue of the act, entitled, An act for the distribution of a certain fund for the purpose of establishing free schools in the several counties therein mentioned, and the manner in which they have disposed thereof; which was read the first, and by special order the second and third time, and assented to.

The bill to authorise a lottery to raise a sum of money for the purpose of cutting and opening a canal from the head of Black Water River to the head of Parsons creek, in Dorchester county, was read the second, and by special order the third time, and will not pass.

The bill authorising Job Smith, of Baltimore county, to remove a certain mulatto girl into the state of Maryland, was read the second, and by special order the third time, and will pass with the proposed amendment. After the title insert the following preamble. "Whereas Job Smith, of the city of Baltimore, hath represented to this general assembly, that he owns a female mulatto slave named Mary Jones, who is at present in Louisiana attending upon his daughter, where she has been for more than a year past; and that it is his wish that the said mulatto slave should be brought back into the state of Maryland, when his daughter shall return; Therefore."

The bill to incorporate the President and Managers of the Shot Tower Company of Baltimore, was read the second and third time by special order and will not pass.

The further supplement to the act, entitled, An act relating to insolvent debtors in the city and county of Baltimore, was read the second, and by special order the third time, and will pass.

The bill for the relief of sundry poor persons in the several counties therein mentioned, was read the second, and by special order the third time, and will pass with the proposed amendments. 1. Insert after 'dollars' 10th line 1st sec. the words 'for William Mason, an afflicted boy, thirty dollars, payable to his mother, or her order' 2. In 18th line 2d page insert after 'dollars' the words 'to Willey Reynolds thirty dollars, payable to her or her order'

The bill authorising a lottery or lotteries for the purpose of finishing the Susquehanna bridge now building at the Conowingo Falls, was read the third time and will not pass.

The senate adjourns until to-morrow morning 10 o'clock.

The bill to authorise the levy court of Cecil county to levy a sum of money for the purposes therein mentioned, was read the second, and by special order the third time, and will pass with the proposed amendment. In 2d line 3d sec. after "compensation" insert "not exceeding twenty dollars each." Sent to the house of delegates.

The bill to establish a patrol in Saint Mary's, Prince George's, Somerset and Charles counties, was read the second, and by special order the third time, and postponed for further consideration.

The bill for the relief of Maria W. B. Beckwith of Talbot county, was read the second, and by special order the third time, and will pass. Sent to the house of delegates.

The bill for the relief of Sally Handy, of Dorchester county, was read the second, and by special order the third time, and will pass. Sent to the house of delegates.

The bill authorising and empowering the levy court of the several counties therein mentioned to discontinue out pensioners, and for other purposes, was read the third time and will pass with the proposed amendment. Strike out from the word "authorised" 3d line enacting clause to the end of the bill, and insert the following: "in their discretion to discontinue such out pensioners as shall not, on or before the annual meeting of the levy courts of said counties, for the purpose of laying the annual levy, produce to them certificates from the trustees of the poor of said counties respectively, that they are respectively in such a situation as renders a continuance of public assistance necessary and proper. And be it enacted, That this act shall not be in force until the first day of January eighteen hundred and twenty two." Sent to the house of delegates.
