

The bill relative to the making of a public landing place and road in Somerset county, was read a third time and will pass.

The bill for the benefit of St. John's college, was read by special order a third time and will pass.

The consideration of the bill entitled, A further supplement to the act entitled, an act for the distribution of a certain fund for the purpose of establishing free schools in the several counties therein mentioned, was on motion, postponed until Tuesday next.

The bill for the benefit of Levin H. Campbell, on motion, was postponed until Tuesday next.

The bill for the benefit of the trustees of the Catholic Cathedral church of Baltimore, was read a third time and will pass.

The bill supplementary to the act entitled, An act to establish a bank and incorporate a company to be styled the Bank of Westminster, was read a third time and will pass.

The bill to alter a road in Harford county, was read a second time and laid on the table.

The bill entitled, a further supplement to an act entitled, A supplement to an act entitled, An act to provide for the opening and extension of Pratt street in the city of Baltimore, was read a second time and referred to Messrs Johnson, M'Kim and Quinton.

The bill to lay out and make public two roads in Cecil county, was read a second time, and on motion the question was put, Will the senate insert the words "Gopin's bridge," after the words "M'Donald's ford," in the 5th line 1st section? Determined in the affirmative, and the bill was laid on the table.

On motion the consideration of the bill to repeal an act for the relief of poor and distressed families in cases of execution for debt and distress for rent, was postponed until Monday next.

The bill entitled, A supplement to the act entitled, An act for the distribution of a certain fund for establishing free schools in the several counties therein mentioned, was read a third time by special order and will pass with the proposed amendment. Amendment proposed. Strike out the word "levy," throughout the bill, and insert the word "orphans."

Mr Johnson from the committee reports a bill entitled, An act to incorporate a company to make a turnpike road from Beonsborough to Hager's town, and for the extension of the charters of the several banks therein mentioned, and for other purposes; which was read and the bill ordered to be printed.

The bill to make valid a deed therein mentioned; the bill for the benefit of St John's college; the bill supplementary to the act entitled, An act incorporating into one the several acts relating to constable's fees; the bill relative to the making of a public landing place and road in Somerset county; the bill for the benefit of the trustees of the Catholic Cathedral church of Baltimore; the bill supplementary to the act entitled, An act to establish a bank and incorporate a company to be styled the bank of Westminster, and the bill supplementary to the act entitled, An act for the distribution of a certain fund for establishing free schools in the several counties therein mentioned, were sent to the house of delegates.

Mr Johnson offered the following as an additional rule to those already adopted for the government of the senate: "No amendment shall be received at the third reading of any bill, resolution, amendment or motion, unless by the consent of two thirds of the member present; but it shall at all times be in order before the final passage of any such bill, resolution, constitutional amendment or motion, to move its commitment; and should such commitment take place, and any amendment be reported by the committee, the said bill, resolution, constitutional amendment or motion, shall be again read a second time, and considered as in committee of the whole, and then the aforesaid question shall be again put."

The senate adjourns until Monday morning 10 o'clock.

MONDAY, January 14, 1822.

The senate met. Present the same members as on yesterday except Mr Kent. The proceedings of Saturday were read.

Mr M'Kim from the committee to whom was referred the petition of the President and directors of the City Bank of Baltimore, reported a bill entitled, A supplement to the act entitled, An act to establish a Bank in the City of Baltimore, to be called the City Bank of Baltimore; which was read the first time and laid on the table.

The resolution relative to public property was read a second time and laid on the table.

The bill to lay out and make public two roads therein mentioned, in Cecil county, was read a third time and will pass with the proposed amendment. Amendment proposed. In the 6th line 3rd section, after the word "county," insert "at the time of making the county levy."

The bill to alter a certain road in Harford county, was read a third time and will pass.

The bill authorising commissioners to make alterations in the election districts of Montgomery county, was read a third time and will pass.

The bill to authorise William D. Davidson, to bring into this state a certain negro therein mentioned, was read a second time and referred to Messrs Bowie, Quinton and Cockey.

The bill to make valid two deeds therein mentioned, was read a second time and laid on the table.

The bill to repeal an act for the relief of poor and distressed families, in cases of execution for debt and distress for rent, was read a second time and referred to Messrs Johnson, Woolton and Orrell.

The bill for the benefit of the heirs of Mary Logan of Harford county, deceased, was read a second time and laid on the table.

The bill to provide for the building of a Bridge over Beaver Creek, in Washington county, was read a second time and laid on the table.
