Mr. Chambers from the committee reported a bill entitled, A supplement to the act entitled, An act to authorise a lottery or lotteries to raise a sum of money for the purpose of repairing and raising a fund for the use of Washington College; which was read the first and by special order a second time and laid on the table.

The resolution in favor of Luther Martin, Esq. was read a second time and made the order of the day for Thursday next.

The bill for the benefit of William Woods, was read a third time and will not pass.

The senate adjourned until to morrow morning at 10 o'clock.

### WEDNESDAY, JANUARY 30, 1822.

The Senate met. Present the same members as on yesterday. The proceedings of yesterday were read.

The additional supplement to the act authorising the appointing inspectors and wood Corders, and to regulate the Cording of fire wood brought by water to the City of Baltimore for sale, and the bill for the relief William Woods, were sent to the house of delegates.

Mr M'Kim submitted the following report:

The committee appointed on the part of the senate to confer with the committee appointed on the part of the house of delegates, on the subject of the Tobacco bills under consideration of both houses, beg leave to report. That the joint committee have had two meetings on the said bills, without coming to any agreement, and seeing no prospect of any decision on the subject referred to them, the said committee agreed to adjourn sine die.

A resolution in favor of Richard Graves, was read a second time and laid on the table.

The bill for the benefit of Henry Korn of Allegany county, was read a second time and referred to Messrs Chambers, M'Kim and Miller.

The bill entitled, An additional supplement to the act to incorporate a company to make a turnpike road from the Frederick and Baltimore turnpike road, commencing at the west end of Frederick town, to Harper's Ferry on the Potomac river, and its supplement was read a second time and referred to Messrs M'Kim, Price and Dickinson.

The resolution in favor of Richard Graves, was read a third time by special order, passed and sent to the house of delegates.

The bill empowering the levy court of Cecil county, at their discretion, to levy a sum of money to build a bridge over Octavara creek, at or near Samuel Roland's store, and the bill for the benefit of Robert Usselton and Benjamin Arno of Kent county, were severally read a second time and laid on the table.

The supplement to the act to prevent the destruction of Oysters in this state. The supplement to the act to confirm and make valid the acts and proceedings of the commissioners of the town of Princess Ann in Somerset county; the bill to lay out and make public a road in Baltimore county; the bill for the relief Elijah Morress, Lydia Anthony and Margaret Wherret of Caroline county, and the bill for the benefit of Elizabeth Dedman and others of Kent county, were severally read a third time, passed and sent to the house of delegates.

The bill authorising Margaret Lewis to remove certain negroes into the state of Maryland, was read a third time and committed to Messrs Chambers, Brownley and Bowie.

The bill for opening roads in Harford county, was read a third time, passed and sent to the house of delegates.

The clerk of the house of delegates delivered a bill to amend and reduce into one the several acts of Assembly relating to the public roads in Worcester county, which was read the first and by special order the second time and laid on the table. Also a bill entitled, A supplement to an act entitled, An act for the preservation of the Navigation of a branch of Nanticoke river, called North West Fork in Caroline county; which was read the first time and laid on the table. Also a bill entitled, A supplement to an act entitled, An act to provide for the erection of an additional Wharf in the town of Nottingham in Prince George's county, and for other purposes, which was read the first and by special order a second time and referred to Messrs Bowie, Miller and Brownley Also a bill entitled, An act to authorise the abutment of a bridge on the Maryland shore of the Potomac river at Harper's Ferry and for other purposes; the bill to authorise the recording of a deed from Jacob Charles of Caroline county, to Thomas Payne of said county; which were severally read the first time and laid on the table.
