

Town, in Frederick county, was read a second time and referred to Messrs. Johnson, Quinton and Dickinson.

The bill empowering the levy court of Harford county, in their discretion, to build two bridges over Deer creek, was read a second time, and laid on the table.

The bill to authorize a lottery for the benefit of the Union church of Taney Town, in Frederick county, was read a second time, and referred to Messrs. Johnson, Quinton and Dickinson.

The bill entitled, A supplement to the act to authorize a lottery to raise a sum of money for the purpose of repairing and raising a fund for the use of Washington College, was read a third time, and the further consideration of the same postponed until to-morrow.

The clerk of the house of delegates delivered a resolution in favor of Solomon Frazier; a bill to appoint commissioners for the purpose of altering the divisional line between the first and fourth election districts in Allegany county; a bill to authorize the establishment of an additional warehouse in the city of Baltimore for the inspection of Tobacco; a bill entitled, A supplement to the act entitled, An act to establish a patrol in Saint Mary's, Anne-Arundel and Prince George's counties, passed December session 1820, chapter 200; a bill appointing commissioners for the regulation and improvement of the village of Hillsborough, in Caroline county; and a bill to make valid a deed therein mentioned; which were severally read the first time and laid on the table.

The further supplement to an act for making certain roads in Baltimore and Harford counties, was read a third time, passed, and sent to house of delegates

The bill relating to public notices in certain cases therein mentioned, was read a second time by special order, and referred to Messrs. Quinton, Bowie and Johnson.

Mr. Bowie from the committee to whom was referred the bill to authorize William D. Davidson to bring into this state a certain negro therein mentioned, reported a bill to authorize officers of the army and navy of the United States to bring into this state such negro or negroes as are employed in and about the house and family of the said officers, as a substitute for the one referred to them; which was read the first time and laid on the table.

On motion of Mr. Johnson, Leave given to bring in a bill to be entitled, An act relating to crimes and punishments in the city of Baltimore. Ordered, that Messrs. Johnson, Chambers and Wootton be a committee to bring in the same.

On motion of Mr. Johnson, Leave given to bring in a bill to be entitled, A supplement to an act entitled, An act relating to runaway servants and slaves. Ordered, that Messrs. Johnson, Miller and Cockey be a committee to bring in the same.

On motion of Mr. Wootton, Leave given to bring in a bill to be entitled, A supplement to an act entitled, An act to establish and incorporate a Medical and Chirurgical Faculty or Society in the state of Maryland, and the several supplements thereto. Ordered, that Messrs. Wootton, Quinton, Claude, Brownley, Miller and McKim be a committee to bring in the same.

Mr. Wootton from the committee to whom was referred the bill for the relief of Roswell Noble, reported the same with sundry amendments; which amendments were read the first, and by special order a second and third time and assented to, and the bill as amended having been read a third time, was passed and sent to the house of delegates.

The bill to authorize officers of the army and navy of the United States, to bring into this state, such negro or negroes as are employed in and about the house and family of said officers, was read a second time and recommitted.

Mr. Chambers from the committee to whom was referred the bill for the benefit of Basil L. Stocker and Ann his wife, William Humes, Levi Stocker and Sarah his wife, and Nancy Humes, reported the same with sundry amendments; which were read the first, and by special order a second and third time and assented to; and the bill as amended having been read a third time, was passed and sent to the house of delegates.

On motion of Mr. Bowie, the bill for the relief of the poor of Anne Arundel county, being supplementary to the act for the relief of the poor of the several counties therein mentioned, was recommitted to Messrs. Bowie, Wootton and Dickinson.

The consideration of the resolution in favor of Luther Martin, was postponed until to-morrow.

On motion of Mr. Claude, the committee to whom was referred the bill for the relief of the poor of Anne Arundel county, being supplementary to the act for the relief of the poor of the several counties therein mentioned, was enlarged, and Messrs. Claude and Johnson added to it.

Mr. Quinton from the committee to whom was referred the bill relating to public notices in certain cases therein mentioned, reported the same without amendments, and the bill was read a third time and recommitted, and again reported, amended, and ordered to lie on the table.

The clerk of the house of delegates delivered a resolution relative to the sale of stock. A further supplement to the act for the distribution of a certain fund for the purpose of establishing free schools in the several counties therein named, and for other purposes; which were read the first time and laid on the table.

Mr. Bowie from the committee to whom was referred the bill to authorize officers of the army and navy of the United States to bring into this state such negro or negroes as are employed in and about the house and family of said officers, reported the same with amendments; which amendments were read the first, and by special order a second time, and with the bill laid on the table.

The senate adjourned until to-morrow morning at 10 o'clock.
