The resolution in favor of Robert C. Lusby, was read a second and third time by special order and assented to.

The clerk of the house of delegates delivered a bill to provide for appointing a commissioner in Montgomery county, for the purposes therein mentioned, and a bill for the relief of Richard Bennet Mitchell, of the city of Baltimore; which were severally read the first and by special order a second time and laid on the table.

The resolution in favor of Thomas Pilloard's securities was read the second and third time by special order and assented to.

The bill for the relief of Sophia Brighly, of Frederick county, was read a third time by special order and will pass.

The resolution in favor of John Kean, was read a second and by special order a third time and dissented from.

The senate adjourned until to morrow morning 10 o'clock.

SATURDAY, FEBRUARY 23, 1822

The Senate met. Present the same members as on yesterday. The proceedings of yesterday were read.

The bill for the relief of Sophia Brighly; the bill to repeal an act for the relief of Edward Godman of Montgomery county; the resolution in favor of John Kean; the resolution in favor of Thomas Pilloard's securities, and the resolution in favor of Robert C. Lusby, were sent to the house of delegates.

The bill for the benefit of the Rector of Saint John's parish, in Harford and Baltimore counties, was read the third time, passed and sent to the house of delegates.

The clerk of the house of delegates delivered a resolution in favor of the Rev. Mr. Rafferty and the Rev. Mr. Emory; which was read the first and by special order the second and third time, passed and sent to the house of delegates. Also a resolution in favor of Ann Rawlings; which was read the first and by special order a second time and laid on the table. And returns the bill relating to coroners for Baltimore county and city, endorsed, 'will pass with the proposed amendment,' which amendment was read and assented to. Also a bill to lay out and make public a road leading from Bean town in Charles county till it intersects the dividing line between Prince George's and said county, near Ignatius Gardener's gate; which was read the first and by special order the second and third time, passed and sent to the house of delegates. Also a bill for the payment of the journal of accounts; which was read the first and by special order the second and third time, passed and sent to the house of delegates. Also the journal of accounts; which was read, assented to and sent to the house of delegates. Also the engrossed bills from No 101 to 125 inclusive, and from 133 to 167 inclusive, which were severally read, assented to, and sent to the house of delegates. Also a bill empowering the levy court of Montgomery county to assess and levy a sum of money for the support and maintenance of the idiot son of John Grant and Virinda Compton; which was read the first and by special order a second time and laid on the table. Also a bill for the relief of the deaf and dumb child of Theophilus Davis, of St. Mary's county; which was read the first and by special order the second time and laid on the table.

The further supplement to the act to incorporate a company under the name of the Hydrant Company of Port Tobacco, was read a third time by special order, passed and sent to the house of delegates.

The bill in favor of James Beacham and Sarah his wife, was read a third time by special order, passed and sent to the house of delegates.

The bill for appointing a commissioner in Montgomery county, and for other purposes, was read a third time and will pass, and was sent to the house of delegates.

The bill for the relief of the deaf and dumb child of Theophilus Davis, of Saint Mary's county, was read a third time, passed and sent to the house of delegates.

The bill for increasing the fees of the examiner and for other purposes, was read a third time and will not pass.

The bill for the relief of Richard Bennet Mitchell, of the city of Baltimore, was read a third time by special order and will not pass, and was sent to the house of delegates.

The bill authorising George Beaton, of Cecil county, to bring into this state from the state of Delaware a certain negro therein mentioned, was read a third time, and will not pass, and was sent to the house of delegates.

The resolution relative to absconding slaves, was read a third time, assented to and sent to the house of delegates.

Mr Johnson from the committee reported a bill entitled, a further supplement to the act relating to insolvent debtors within the city and county of Baltimore; which was read the first and by special order a second and third time, passed and sent to the house of delegates.

The bill for the relief of Fielding A Purnell, of the city of Baltimore, was read the third time, passed and sent to the house of delegates.

The resolution in favor of Ann Rawlings, was read a third time, assented to, and sent to the house of delegates.

The resolution in favor of Ann Jackson, was read a third time, assented to, and sent to the house of delegates.
