The bill to appoint commissioners for the purpose of dividing Dorchester county into six seperate election districts; the bill to confirm an act to alter and repeal such parts of the constitution and form of government of this state as relates to the division of Frederick county into

election districts; were read a third time, passed, and sent to the house of delegates.

Mr. Chambers from the joint committee appointed to wait on the governor elect for the purpose of knowing when it would be convenient for him to qualify, informed the senate that the governor elect would appear in the senate chamber at one o'clock, for the purpose of qualifying according to the constitution and form of government.

The bill to ascertain and establish the divisional line between Anne-Arundel and Calvert

counties, was read a third time, passed and sent to the house of delegates.

The clerk of the house of delegates delivered a bill entitled, An act appointing commissioners for the regulation and improvement of the village of Hillsborough, in Caroline county; a bill entitled, An act for the benefit of Dennis Hill and, Sophia Liviss, of Frederick county; a bill entitled, An act for the benefit of Phebe Sutton, of Kent county; a bill entitled, An act to settle and ascertain the salary of the members of the council for the ensuing year; a bill entitled, An act to make valid the proceedings of the levy court of Allegany county; which were severally read the first time and laid on the table.

Samuel Stevens, Jr. the governor elect, attending in the senate chamber, Ordered, That Messrs. Chambers and Dickinson inform the house of delegates, that Samuel Stevens, Jr. the governor elect, is attending in the senate chamber to qualify as governor of the state of Mary-

land, and request their attendance.

The speaker of the house of delegates, attended by the members, appeared in the senate chamber, and Samuel Stevens, Jr. qualified as governor, before the president of the senate, in the presence of both houses, by taking the oaths directed by the constitution and form of government, the oath of office prescribed by law, and by taking the oath to support the constitution of the United States, and also by subscribing a declaration of his belief in the christian religion. The Senate adjourned until to-morrow morning 10 o'clock.

The president laid before the senate a report from the agent of the state for the western shore, accompanied by sundry documents; which was read and ordered to lie on the table.

a second time and laid on the table.

Mr. Johnson from the committee to whom was referred the memorial of Jonathan Ellicott, Elias Ellicott, and others, of the city of Baltimore, reported a bill entitled, An act to incorporate a company in Baltimore county by the name of the Avalon company; also a bill entitled, An act to incorporate a company in Baltimore county by the name of the Baltimore Manufacturing company; which were severally read the first time and laid on the table.

On motion by Mr. Johnson, Leave was given to bring in a bill to be entitled, An act to alter and change such parts of the constitution and form of government of this state as requires the officers thereof to subscribe a declaration of belief in the christian religion; it was ordered, That Messrs. Johnson, Dickinson and Claude, be a committee to prepare and bring in the same
