the resignation, death, or refusal to act, or any other cause, of one or more of the said commissioners, the governor and council are hereby authorised and required to fill such vacancy or vacancies, so occuring by appointing a commissioner or commissioners as the case may be.

3d. And be it enacted, that either of the said commissioners shall have power to administer the following oath, (or affirmation,) to such witnesses as may appear or be produced before them: You, A B. do solemnly swear, (or affirm as the case may be,) that the evidence you are about to give, shall be the truth, the whole truth, and nothing but the truth; so help you God."
