Mr. Johnson, from the committee, to whom was referred the bill to incorporate the Asbury Sunday School Society, reported that the committee had had the same under consideration, and were of opinion that it ought to pass.

The bill was then read a third time, and the question was put, shall the bill pass? Determined

in the affirmative, and it was sent to the house of delegates.

Mr. Wootton, from the committee, reported a bill for the relief of George Gingle, of Montgomery county; which was read the first time and laid on the table.

The clerk of the house ordelegates delivered a bill, entitled, An act for the benefit of Dennis
