The resolution was then read a second time, and by special order a third time assented to, and returned to the house of delegates.

The clerk of the house of delegates delivered a resolution in favor of the examiner general;

which was read the first time, and referred to Messrs. Johnson, Bowie and Dickinson.

Also a bill entitled, An act to release the right of the state to part of a tract of land therein

mentioned; which was read the first time and laid on the table. The bill entitled, An additional supplement to an act to incorporate a company to make the several turnpike roads therein mentioned, was read a third time, rejected, and returned to the house of delegates.

Mr. Bowie asked leave to bring in a bill to be entitled, An act relating to the Farmers' Bank of Maryland and the Planters Bank of Prince George's county; and the question was put, will

the senate grant the leave as asked? Determined in the negative.

The cierk of the house of delegates delivered a bill entitled, An act relating to the public roads in the counties therein mentioned, and a bill entitled, A supplement to an act to incorporate a company to make a wharf at the town of Cambridge, in Dorchester county; which were read the first time and laid on the table.

The resolutions relating to the University of Maryland, were read a second time, and made

the order of the day for Monday next.

On motion by Mr. Bowie, leave was given to bring in a bill to be entitled, An act explanatory of the act entitled, Anact to prevent the issuing of small bank notes. And it was ordered, that Messrs. Bowie, Chambers and Wootton, should be a committee to prepare & bring in the same. The senate adjourned until to-morrow morning at 10 o'clock.

SATURDAY, February 1, 1823.

The senate met. Present the same members as on yesterday. The proceedings of yesterday were read.

The bill for the relief of George Gingill, of Motntgomery county, was read a third time, pas-

sed, and sent to the house of delegates.

The bill to incorporate a society in the city of Baltimore by the name of the Second Franklin Beneficial Society of Maryland, established at Baltimore, was read a third time, passed, and sent to the house of delegates.

Mr. Miller presented the petition of Thomas Aitkins, of Cecil county, praying for a law authoursing the levy court of Cecil county to levy a sum of money for his benefit; which was read

and referred to Messrs. Miller, Brownley and Cockey.

Also the memorial of the president and directors of the Susquehannah Canal Company;

which was read and referred to the house of delegates.

Mr. Johnson presented the memorial of Wm. H. Murray, and Maria his wife, of the city of Baltimore, praying to be authorised to lease certain property in said city; which was read and referred to Messrs. Johnson, Kent and Dickinson.

The clerk of the house of delegates delivered a bill, entitled, An act to authorise the county clerks of this state, to judge and approve of security in certain cases therein mentioned; which

was read the first time and laid on the table.

Also a bill, entitled, An act to confirm the name of James Cropper, alias James M'Cellis-

ter, of Dorchester county; which was read the first time and laid on the table.

Mr. Johnson from the committee, to whom was referred the memorial of William H. Murray, and Maria his wife, reported a bill, entitled, An act for the benefit of William H. Murray, and Maria his wife; which was read the first, and by special order a second time, and ordered to be engrossed for a third reading.

Mr. Johnson from the committe, to whom was referred the bill to incorporate the Columbian Beneficial Society, reported, that the committee had had the same under consideration, and

were of opinion that it ought to pass.

The bill was then read a third time, passed, and returned to the house of delegates. Mr. Johnson from the committee, to whom was referred the bill for the benefit of the commissioners of the tax for Baltimore county reported that the committee had had the same under consideration, and were of opinion that it ought to pass.

The bill was then read a second, and by special order a third time, passed, and returned to

the house of delegates.

The bill relating to the third & fourth districts for choosing electors of president & vice president of the United States, was read a second time, and the further consideration of the

same postponed until Monday the third instant.

Mr. Johnson, from the committee, to whom was referred a bill, entitled, An act for the benefit of William Usselton and Simon Beck, of Kent county, soldiers of the revolution, reported, that the committee had had the same under consideration, and were of opinion that it ought to

The bill was then read a second, and by special order a third time, amended, passed, and re-

turned to the house of delegates.

The bill, entitled, A supplement to an act, entitled, An act to make a turnpike road from Boonsborough to Hager's-Town, and for the extension of the charters of the several banks in the state, was read a third time, passed, and returned to the house of delegates.

Mr. Johnson, from the committee, to whom was referred a supplement to an act, entitled, An act respecting certain land certificates, reported, that the committee had had the same under consideration, and were of opinion that it ought to pass,

The bill was then read a second time and laid on the table,

The bill relinquishing the right of the state of Maryland to certain land therein referred to,
