six votes. For the Mechanics' Bank, Tobias E. Stansbury had fifty seven votes, and William Stewart fifty five votes. For the Farmers' Bank of Maryland, John Johnson had fifty nine votes and Nicholas Brewer forty six votes. For the Branch Bank at Easton, William Clark had fifty six votes, and Lambert Spencer had fifty one votes. For the Hager's-town Bank, Daniel Schnebly had fifty one votes, and John Buchanan had forty nine votes. For the Elkton Bank, John Mashtt had eighteen votes, and George Beaston thirty sour votes.

Whereupon it was declared in the senate, that William Stansbury and William Pinkney for the Union Bank of Maryland; John Barney and C. C. Egerton, for the Commercial and Farmers' Bank; Tobias E Stansbury and William Stewart, for the Mechanic's Bank; John Johnson and Nicholas Brewer, for the Farmers' Bank of Maryland; William Clark and Lambert Spencer, for the Branch Bank at Easton; Daniel Schnebly and John Buchanan, for the Hager'stown Bank, and George Beaston, for the Elkton Bank, are duly elected directors on the part of the state, for and during the time prescribed by law.

On motion by Mr. Miller, the following resolution was read and unanimously adopted: Resolved unanimously, I hat the thanks of the senate be presented to William R. Stuart, Esq.

for the impartial, able and dismined discharge of his duties as president.

Mr. Johnson from the committee on revolutionary pensions reported unfavorably on the resolution in favor of Zachariah Roberts. Which report was concurred in. The resolution was then read a second and third time by special order and rejected.

A.r. Johnson offered the following message; which was read.

BY THE SENATE, February 22, 1823.

Gentlemen of the House of Delegates-The senate have rejected the resolution in favor of Zachariah Roberts of the city of. Baltimore, and as they understand his situation is such, that the money given by it could not, with propriety be paid to him, if you provide for its payment to some one else in Baltimore for his use, the senate will accede to it.

The clerk of the house of delegates delivered a resolution in favor of the chaplains; a bill to incorporate a company to make a turnpike road from Hancock, in Washington county, to the Pennsylvania line, in the direction leading to Bedford in Pennsylvania; and a bill to authorise Addison Belt, of Montgomery county, to import certain slaves into this state.
