think, however, that the state could pay at this time forty thousand dollars, and if a resolution for that purpose be presented to them, it would meet their approbation.

The resolution in favor of James Ruark, of Anne Arundel county, was read, rejected, and

returned to the house of delegates.

The resolution in favor of Margaret Hamilton, was read a third time, rejected, and returned

to the house of delegates.

Mr. johnson, from the committee on revolutionary pensions made an unfavorable report upon the resolution in favor of William Simmons; which was concurred in. The resolution was then twice read, rejected, and returned to the house of delegates.

Mr. Johnson, from the same committee, reported unfavorably upon the resolution in favor of John Smith, of Prince George's county; which report was concurred in. The resolution was

then twice read, assented to, and returned to the house of delegates.

The clerk of the house of delegates delivered a resolution to extinguish the state debt; which

was three times read, assented to, and returned to the house of delegates.

A bill, entitled, An act to withdraw the donation now given the Harford Academy, and apply the same to the education of poor children; which was read the first, second and third time, rejected, and returned to the house of delegates.

A bill, entitled, An act for the benefit of certain persons who naturalized under the laws of this state; which was read the first, second and third time, passed, and returned to the house of

delegates.

And returns the bill, entitled, A further additional supplement to the act for the distribution of a certain fund, for the purpose of establishing free schools in the several counties therein named, endorsed, "will not pass."

and third time by special order, assented to, and returned to the house of delegates,

Mr. Johnson, from the committee on revolutionary pensions, reported favorably on the resolution in favor of Mary Richards, of the city of Baitimore; which report was concurred in. The resolution was then three time read, assented to, and returned to the house of delegates.

Mr. Johnson submitted the following report; which was read.

The joint committee of the senate and house of delegates, appointed to communicate with the legislature of Pennsylvania concerning the growing evils occasioned the citizens of this state, by the encouragement runaway slaves receive from some of the citizens of Pennsylvania, beg leave to report— That in pursuance of the duty imposed on them, they at an early period of the session, addressed a letter to the legislature of Pennsylvania, stating the serious injuries the people four state suffered, and requesting Pennsylvania to make such legislative provisions as would effectually guard against their repetition. On the receipt of this letter, the legislature of Pennsylvania, without loss of time, instituted a joint committee to consider of it, and that committee sent to the undersigned a communication, dated the middle of February, which is herewith submitted.
