Disposition of the same at May term, eighteen hundred and twenty-one, continued generally, thirty-five; continued under decree, ten; final decree, four; total forty-nine. Number of causes on the Chancery docket, to October term, eighteen hundred and twenty-one, bills of complaint, forty-five; bills on the equity side of court, six; petitions one; total fifty-two. Disposition of the same at October term, eighteen hundred and twenty-one, continued generally, thirty-nine; continued under decree, twelve; final decree, one; total fifty-two. Number of causes on the Chanchery docket, to May term, eighteen hundred and twenty-two, bills of complaint, forty-nine; bills on the equity side of court, eight; petitions one; total 58. Disposition of the same at May term, eighteen hundred and twenty-two, continued generally, forty; continued under decree, twelve; final decree six; total fifty-eight. Number of causes on the Chancery docket to October term, eighteen hundred and twenty-two, bills of complaint, forty-five; bills on the equity side of court six; petitions one; total fifty-two. Disposition of the same at October term, eighteen and twentytwo, continued generally thirty-seven; continued under decree ten; final decree five; total fifty-At May term, eighteen hundred and and twenty, twelve criminal causes were tried by the presentments found as follows, to wit. eighteen hundred and eighteen, jury, the presentments two; eighteen hundred and nineteen two; eighteen hundred twenty, eight; total tweive. At October term, eighteen hundred and twenty, four criminal causes were tried by jury, the presentments found in eighteen hundred and twenty. Three hundred and minetysentiments found in eighteen hundred and twenty. Three hundred and ninety-five presentments have been made within the last three years, and have been disposed of as follows, viz: forty tried by jury; one hundred and three tried by court: cighty-one dismissed; one hundred submitted; one removed to Kent county; two discontinued noll preseq. and sixty-eight continued to May term, eighteen hundred and twenty-three. Of the number tried, seventy-eight acquitted and sixty-five convicted. What portion of each term has been appropriated to the trial of criminal cases, I am unable to say. No information can be given with respect to the portion of each term de oted to hearing of appeals. The following shews the number of causes sent up to the court of appeals of the Eastern Shore, within the last three years, eighteen hundred and twenty, nine; eighteen handred and twenty-one, thirty-seven; eighteen hundred and twenty-two, twenty; total sixtysix. Of the above cases, five have been returned on procedendo; the clerk of the court of appeals only, can furnish the information as to the number affirmed. Queen Ann's county court, at May term, eighteen hundred and twenty, commenced its session on Monday the first, and continued by adjournments from day to day, (sundays excepted) until the threteenth of the same month, then adjourned to Friday the twenty-sixth; sat again on thirty-first of same month, and continued by adjournments until third of June, and then adjourned until the court in course. October term, eighteen hundred and twenty, commenced on Monday the sixteenth day of the same month, and continued by adjournment from day to day, (sundays excepted) until twenty-eighth of same month and then adjourned to Friday third November; sat again on Saturday twenty-fifth and Tuesday twenty-eighth of same month, and then adjourned until the court in course. May term eighteen hundred and twenty-one, commenced on Monday the 7th, and continued by adjournments from day to day, (sundays excepted) until nineteenth of same month and then adjourned to Friday first of June; sat again on the second and eleventh, and continued by adjournment to the 13th of same month, then adjourned to Monday, 16th July, & continued by adjournment until 21st of same month, and adjourned until the court in course. Oct. term, 1821, commenced on Monday the fifteenth of October and continued by adjournment from day to day, (sundays excepted) until the twenty-ninth of same month, and then adjourned to 'Vednesday thirty-first of same month, and adjourned until court in course. May term, eighteen hundred and twenty-two, commenced on Monday sixth, and continued by adjournment from day to day, (sundays excepted) until seventeenth of same month; sat again on the thirty-first, and adjourned to Tuesday, eleventh of June; sat again on Monday, first of July, and then adjourned until the court in course.
