chester county; which was read the first time, and laid on the table.

Mr. Hinder from the committee to whom was referred the bill to authorise the levy court of Queen Ann's county, to pay the funeral expenses of paupers out of the poor house of said county, reported that the committee had had the same under consideration, and were of opinion that it ought to pass with the following amendments, viz:—1st strike out the words, "the levy court of Queen Ann's county," in the enacting clause, and insert in lieu thereof "the levy courts of the several counties in this state. 2d, strike out the word "county," in the fourth line of the enacting clause, and insert counties. 3d, strike out the words, "the levy court of Queen Ann's county," in the title of the bill," and insert in lieu thereof," the levy courts of the several counties of this state." ral counties of this state."

Which amendments were read and assented to, and with the bill ordered to lie on the table.
