The bill to make public a road leading from Coalsville, in Montgomery county, to intersect the public road leading from Vansville, in Prince George's county, at or near the Paint Chapel

in said county, was read a third time, passed and returned to the house of delegates.

The further supplement to the act to establish a bank and incorporate the subscribers there-

to, was read and referred to the first day of June next.

The bill to repair the highways and bridges in certain parts of the city of Baltimore, was read a second and by special order a third time, passed and returned to the house of delegates. The bill to prevent the opening of the old road therein mentioned, in Anne Arundel county, was twice read, passed and returned to the house of delegates.

Mr. Claude from the committee to whom was referred the bill for the relief of James W. Reeves, of Charles county, reported, that the committee had had the same under consideration, and were of opinion that it ought not to pass. The bill was then twice read, rejected, and

returned to the house of delegates

BY THE SENATE, Feb. 24, 1824.
