This house tooke further into consideration that part of y<sup>e</sup> Bill & Entituled an act for the defence of y<sup>e</sup> Province Relating to the pay of Souldiers, And upon debate finde it absolutely Necessary y<sup>t</sup> some horse be maintained in this Province it being found y<sup>t</sup> a Troope of horse can March with greater Security and lesse Charge then 200 foot And therefore are of Opinion that there ought to be 30<sup>00</sup> Tobacco allowed y<sup>e</sup> yeere for every Troope of y<sup>e</sup> shall be Comanded out ag<sup>t</sup> the enemy to Range the finding himselfe provision and onely 20<sup>00</sup> Tob<sup>o</sup>: y<sup>e</sup> yeere, when he Marches with the foot and is allowed provision with the foot at y<sup>e</sup> Countreys Charge.

And it was further Considered that in y<sup>e</sup> last warre all persons were much unsatisfied with the way of Raising provision and other necessaries for y<sup>e</sup> warre and therefore this house desire the Lower house to Consider of a more equall way of Raising y<sup>e</sup> provision and other necessaries for a warre and likewise whether it be not better y<sup>t</sup> every house holder provide and send soe much provision as will maintain all those men that are pressed out of his house for one month and soe from month to month, or that every house holder throughout the Province procure and send soe much provision and other necessaries as shall be agreed upon by an equall assessment upon all the freemen of the Province.
