- 28: An Act concerning setting up a Mint, within this Province, Made Anno: 1661. This Act Corrected and agreed to.
- 29: An Act for port Dutys and Masters of Ships: (Made A<sup>o</sup>: 1661: This Act Corrected and agreed to.
- 30: An Act Concerning purchasing a State House and Prison, (Made A<sup>o</sup>: 1661. This Act Corrected and agreed to.
- 31: An Act Imposing a penalty on such as shall dispose of Tobaccos seized and received by the Sher<sup>o</sup>: and others: This Act is agreed to be repealed by an Act, Made A<sup>o</sup>: 1678.
- 32: An Act for Repeale of a Act Concerning Killing of Cattle.
- 33: An Act for preservacion of Harbours within this Province, Made Anno: 1663: and 64: Corrected and agreed to.
- 34: An Act Concerning Negroes and other Slaves: (Made Anno: 1663 and 64: This Act is agreed to be repealed, in Anno: 81: Except . . . . .
- 35: An Act for Appoynting Coroners in each respective County: Made Anno: 10<sup>th</sup>: 1666: Corrected and agreed to.
- 36: An Act for Confirmation of the Articles of peace Made with y<sup>e</sup> Indians: (Made A<sup>o</sup>: 1666: This Act Corrected and agreed to.
- 37: An Act prohibiting Com<sup>rs</sup> Sher<sup>o</sup> and C<sup>l</sup>ks. to plead as attornies in their respective County Courts: (Made A<sup>o</sup>: 1666: (Misplaced in all the Transcripts but read in its proper place, Corrected and agreed to.
- 38: An Act prohibiting y<sup>e</sup> office of Clerk and Sher<sup>o</sup> to be officiated at one and y<sup>e</sup> same time by one and y<sup>e</sup> same person: (Made A<sup>o</sup>: 1666: This Act Corrected and agreed to.
- 39: An Act for y<sup>e</sup> explanation of a Clause in an Act, Made by Capt: Stone. Touching Hoggz and Marking Cattle. This Act left to be debated.
- 40: An Act for Improving y<sup>e</sup> Govern<sup>o</sup> and Council to make peace or war without the bounds of the Province: (Made A<sup>o</sup>: 1666. This Act is repealed by an Act (Made A<sup>o</sup>: 1678.
- 41: An Act for publishing all Lawes within this Province, Made A<sup>o</sup>: 1666: This Act Corrected and agreed to.
- 42: An Act for continuance of Peace with and protection of our Neighbouring and Confederate Indians in Choptank River, Made Anno: 1669: This Act is Corrected and agreed to: Except the last Auditing Clause and proviso, which is not revived.
