The House resolves into a Grand Committee, and adjourns into the Councill Chamber. Where were present of the upper House as yesterday.

Then was read an act for ^{the} Recording of Journalls of the Lower House.

Made Anno: 1669: and agreed ^{to} word Adjournment, be left out of the act.

An act for ^{the} Encouragement of such as shall build water Mills.

Made Anno: 1669: Corrected and agreed too, ^{the} last clause being repealed.

An act for Encouraging the Importacion of Negroes and Slaves into this Province, Made ^{the} 7th of March 1671: Corrected and agreed to.

An Act Impowering ^{the} Commissioners of ^{the} County Courts to Levy and Rayse Tobacco, towards the defraying the Necessary Charges of their County.

Made Anno: 1671: Corrected and agreed too.

An Act Making void and punishing all Fraudulent Practices tending to ^{the} defrauding of all real purchasers and Creditors, Made Anno: 1661.

Agreed too, and Corrected.

An Act Quietting Possession, Made Anno: 1761. Corrected and agreed too.

An act for ^{the} Rayeing and Providing a Support, for his ^{High} Lordship during his naturall life; and likewise a supply towards the defraying the publique Charge of the Government, Made Anno: 1671.

This act having relation to an Act afterwards Made: Entituled

An act of Gratitude to his Excellency Charles Calvert ^{Esq}: Anno: 1674: to stand according to ^{the} true Meaning thereof, unless otherwise by his

Lord: and two Houses agree to ^{the} contrary.

The Committee adjourns to the house.

This act is repealed by an Act Made Anno: 1681.

An act for Enrolment of Conveyances and securing the Estates of purchasers, Made Anno: 1674: Corrected and agreed to.

An act for appointing Court days in each respective County within this Province, Made Anno: 1674: This act to be amended by

appointing a Court day for Cecil County.

An act declaring what shall be done by ^{the} Sheriffs Officers, Made
