And seeing since the last Meeting of Assembly your Lopp<sup>s</sup> in Order to the  
better settling  $\text{y}^{\text{e}}$  Laws of this Province) hath caused the Laws of this Province  
to be fairly transcribed and hath made three Copies thereof offering  
the same to  $\text{y}^{\text{e}}$  Consideracon of your Lopp<sup>s</sup> two Houses for their View, and full  
Approbacion and Amendment thereof and asent to  $\text{y}^{\text{e}}$  same, that doe  
after due Examination of them they might with the advise and Consent  
of your Lopp<sup>s</sup> two Houses receive their full Oygours and force by your Lopp<sup>s</sup>  
asent and Confirmacion.

(Now may it further please your Lopp<sup>s</sup> your Lopp<sup>s</sup> two Houses of  $\text{y}^{\text{e}}$   
Assembly in  $\text{y}^{\text{e}}$  first place hereby) returning your Lopp<sup>s</sup> their most humble  
and hartly thanks for your Lopp<sup>s</sup> great Kindness, Love and affection and  
studious Care for the good and welfare of the good people of this your Lopp<sup>s</sup>  
Province - Doe in the most place humbly assure your Lordship that  
in Obedience to your Lopp<sup>s</sup> Commands, they have carefully and diligently  
revised and Examined the said three Transcripts of the Laws aforesaid  
and Compared them with  $\text{y}^{\text{e}}$  ancient Booke of Laws, and of such  
originals as came to our View in  $\text{y}^{\text{e}}$  passing and Examining whereof,  
they have found some Errors and Mistakes, and made Observations for  
some Necessary Amendments to severall acts in the ancient Booke of Laws  
as in the Copies or transcripts, and have reduced the titles of all  $\text{y}^{\text{e}}$   
perpetuall Laws, by your Lopp<sup>s</sup> two Houses of Assembly desired to be Con-  
firmed into a Schedule hereunto annexed, with such Necessary  
amendments to the same, to be new drawn over, as to your Lopp<sup>s</sup> shall

ingrossed in a booke for that purpose, To all which perpetuall Laws added

unto and Approbacion and Confirmacion thereof, and Cause the same  
to be fairly ingrossed in a booke for that purpose and that all other  
 $\text{y}^{\text{e}}$  perpetuall Laws and acts of Assembly heretofore made and  
published in this Province of what kind or quality soever, other than  
what are in the Schedule hereunto annexed mentioned and amended  
as aforesaid, And by the Consent of your Lopp<sup>s</sup> and both Houses thought fit  
to be entered in the new booke aforesaid may stand and be forever absolutely  
Repealed.
