

Capt. Smith and Mr. Green returned, and say they cannot deliver their message, because the Lower house is adjourned.

Then this house proceed to Consider the petition mentioned in the message by Secy. Darnall.

And upon Reading the petition of the Inhabitants of Somerset County for a Towne at  $\text{P}^{\text{e}}$  Sea Side, Ordered that a Towne be appointed  $\text{+}$  between the going into Selbyes Bay and Cornelius Jones his land at  $\text{+}$  Hbateque bay at the discretion of the Commissioners: but, voted that  $\text{P}^{\text{e}}$  Towne at Barrows landing not to be removed nor altered.

The petition of  $\text{P}^{\text{e}}$  Inhabitants of Lacajah Swamps in  $\text{P}^{\text{e}}$  Mays  $\text{+}$  County was read, and voted that there be a towne at Westwood Mannors as by this petition is desired.

Upon Consideration of the petition of  $\text{P}^{\text{e}}$  Inhabitants of Wansmy Creeke in Charles County, voted that a towne be layd out at the Mouth of Wansmy Creeke at or near Lewis his neck as is desired by  $\text{P}^{\text{e}}$  petition.

All the sayd petitions referred to  $\text{P}^{\text{e}}$  Committee for drawing the Supplementary Act to  $\text{P}^{\text{e}}$  Act for Trade.

The house adjourned till to Morrow Morning 8 a clocke.

The house mett, and called, all present as Yesterday.

Then was read what was done Yesterday.

The Committee for drawing up the bills and Amendments, agreed on by the Grand Committee of both houses, goe upon their Charge.

Then was taken into further Consideration of this house,  $\text{P}^{\text{e}}$  petition brought Yesterday by Mr. Secy. Darnall.

The petition of the Inhabitants of Mannokin River in Somerset County about a Towne read and Rejected.

The petition of the Inhabitants of Somerset County about linen and woollen cloth, read and Rejected.

Upon Motion of  $\text{P}^{\text{e}}$  Delegates for Cecil County - A Towne is ordered to be layd out, at Meeting house point in Sassafras River in  $\text{P}^{\text{e}}$  County.

Upon Motion of the Delegates for  $\text{P}^{\text{e}}$  Mays County, voted that a Towne be sett forth at Brittons neck in  $\text{P}^{\text{e}}$  Mays County.

Upon Motion of  $\text{P}^{\text{e}}$  Delegates of Dorchester County, voted that a Towne be appointed at Daniell Jones Plantation, on  $\text{P}^{\text{e}}$  South Side of Great  $\text{+}$   $\text{+}$   $\text{+}$  Choptank River.

Upon Motion of the Delegates of Ann Arundell County, voted that there be a towne at West River upon the Land late of John Heilin deceased and the Lands adjacent.

Upon Motion of  $\text{P}^{\text{e}}$  Delegates of Calvert County voted that there be a Towne at Coxes Creeke or the lands adjacent - Instead of the towne appointed in the act for Trade, to be at John Bowlings Lands.
